COMMON GAMING HOUSES ACT (CHAPTER 49)

COMMON GAMING HOUSES (EXEMPTION) (NO. 68) NOTIFICATION 2016

ARRANGEMENT OF PARAGRAPHS

In exercise of the powers conferred by section 24 of the Common Gaming Houses Act, the Minister for Home Affairs makes the following Notification:

Citation

1. This Notification is the Common Gaming Houses (Exemption) (No. 68) Notification 2016.

Exemption

2.—(1) The Minister exempts Resorts World at Sentosa Pte. Ltd. from the provisions of the Act in respect of —

- (a) the “Premium Ang Bao” promotion to be held from 14 December 2016 to 4 February 2017 (both dates inclusive); and
- (b) the “Instant Dip Ang Bao” kiosk game to be held as part of that promotion at the Maxims Club (Level B1M) at Resorts World Sentosa Singapore from 8 p.m. to 11.59 p.m. daily from 2 February 2017 to 4 February 2017 (both dates inclusive).

(2) The exemption is subject to compliance by Resorts World at Sentosa Pte. Ltd. with the conditions specified in the Schedule.

THE SCHEDULE

Paragraph 2

CONDITIONS

1. The methodology of the promotion, the details of the prizes to be distributed, their manner of distribution and, where the winners are determined solely or partly by a lottery, the time, date and place of the lottery, must be disclosed in printed publicity material, copies of which must be freely available to all participants.
2. Only persons in the employment of Resorts World at Sentosa Pte. Ltd. may conduct a lottery.
3. Each lottery must —
 - (a) be conducted in public; or
 - (b) if conducted in private by means of a computerised system, be witnessed and audited by a public accountant who is not in the employment of Resorts World at Sentosa Pte. Ltd.
4. A lottery must not involve the use of any game, method, device, scheme or competition declared by the Minister under section 2(3) of the Act to be a lottery or a game of chance or of mixed chance and skill.
5. A lottery must not involve the use of any article declared by the Minister under section 2(4) of the Act to be an instrument or appliance for gaming.
6. Resorts World at Sentosa Pte. Ltd. must, before the start of the lotteries, undertake to ensure that an audited statement of accounts and the results of the lotteries are sent by registered post to the Head, Specialised Crime Policy Branch, Criminal Investigation Department, no later than 5 May 2017.
