In exercise of the powers conferred by section 65B(1) of the Housing and Development Act, the Minister for National Development, after consulting the Housing and Development Board, hereby makes the following Order:

Citation and commencement

1. This Order may be cited as the Housing and Development (Precincts for Upgrading Works) (Home Improvement Programme) (No.4) Order 2013 and shall come into operation on 3rd October 2013.

Declaration of precincts for Home Improvement Programme

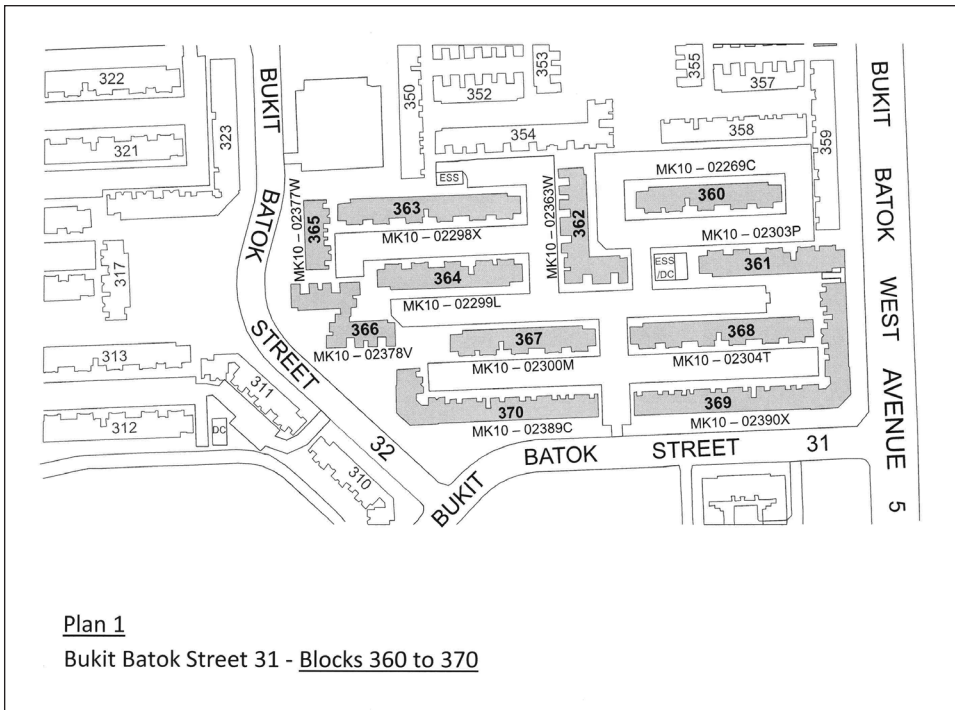
2. The parts of the housing estates of the Board described in the Schedule are hereby declared to be precincts for the purpose of carrying out upgrading works in connection with the Home Improvement Programme.

THE SCHEDULE

1. All that part of the housing estate of the Board at Bukit Batok Street 31 comprised in Lot numbers 02269C, 02303P, 02363W, 02298X, 02299L, 02377W, 02378V, 02300M, 02304T, 02390X and 02389C in Mukim 10 and on which Apartment Blocks 360, 361, 362, 363, 364, 365, 366, 367, 368, 369 and 370 are erected, and which is more particularly shaded in Plan 1.

BUKIT BATOK STREET 31

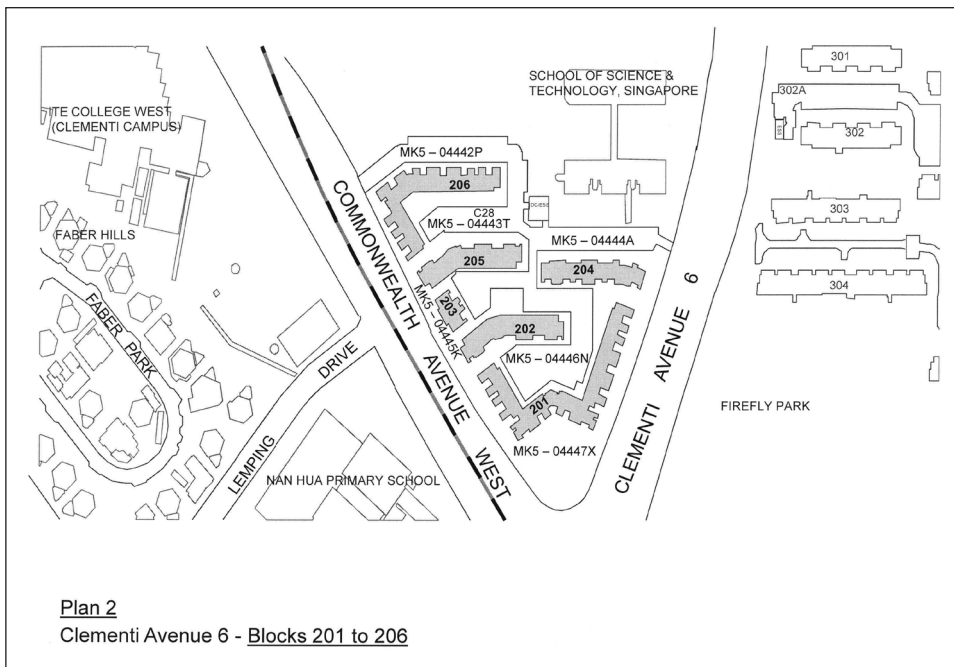

2. All that part of the housing estate of the Board at Clementi Avenue 6 comprised in Lot numbers 04447X, 04446N, 04445K, 04444A, 04443T and 04442P in Mukim 5 and on which Apartment Blocks 201, 202, 203, 204, 205 and 206 are erected, and which is more particularly shaded in Plan 2.

CLEMENTI AVENUE 6

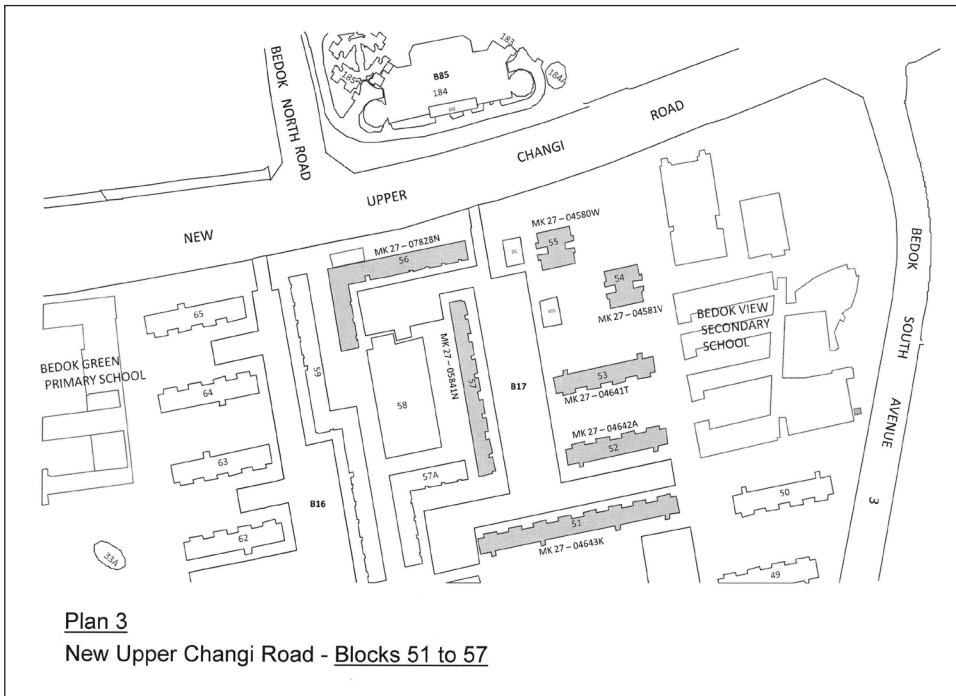
