## Citation and commencement

- 1.—(1) This Order is the Corruption, Drug Trafficking and Other Serious Crimes (Confiscation of Benefits) Act 1992 (Amendment of First and Second Schedules) Order 2023 and, except for paragraph 3(c), comes into operation on 25 September 2023.
- (2) Paragraph 3(c) is deemed to have come into operation on 31 December 2021.

  - (b) in Part 13, in item 393, in the first column, after "Section 27A(5)", insert "(as in force before 28 April 2023)";
  - (c) in Part 23, in the first column, delete "(Act 22 of 2021)"; and
  - (d) after Part 26, insert —
