ROAD TRAFFIC
(ELECTRONIC ROAD PRICING SYSTEM)
(AMENDMENT NO. 5) RULES 2017

In exercise of the powers conferred by section 34D of the Road Traffic Act, the Minister for Transport makes the following Rules:

Citation and commencement

1. These Rules are the Road Traffic (Electronic Road Pricing System) (Amendment No. 5) Rules 2017 and come into operation on 6 November 2017.

Amendment of First Schedule

2. The First Schedule to the Road Traffic (Electronic Road Pricing System) Rules 2015 (G.N. No. S 226/2015) is amended —

(a) by deleting Division 2 of Part 18 and substituting the following Division:
