RAPID TRANSIT SYSTEMS ACT (CHAPTER 263A)

RAPID TRANSIT SYSTEMS (FEES) (AMENDMENT NO. 2) REGULATIONS 2016

In exercise of the powers conferred by section 45 of the Rapid Transit Systems Act, the Land Transport Authority of Singapore, with the approval of the Minister for Transport, makes the following Regulations:

Citation and commencement

1.—(1) These Regulations are the Rapid Transit Systems (Fees) (Amendment No. 2) Regulations 2016 and, except for regulation 3(a), (*b*) and (*c*), come into operation on 20 December 2016.

(2) Regulation 3(b) comes into operation on 1 January 2017.

(3) Regulation 3(*a*) and (*c*) comes into operation on 1 April 2017.
