ROAD TRAFFIC ACT 1961

ROAD TRAFFIC (MOTOR VEHICLES, REGISTRATION AND LICENSING) (AMENDMENT NO. 4) RULES 2024

In exercise of the powers conferred by sections 34 and 140 of the Road Traffic Act 1961, the Minister for Transport makes the following Rules:

Citation and commencement

1. These Rules are the Road Traffic (Motor Vehicles, Registration and Licensing) (Amendment No. 4) Rules 2024 and come into operation on 2 August 2024.

Amendment of rule 8

- **2.** In the Road Traffic (Motor Vehicles, Registration and Licensing) Rules (R 5), in rule 8
 - (a) in paragraph (15)(c)(i), after "a specified Comfort taxi", insert ", a specified Comfort or CityCab diesel taxi, a specified hybrid taxi";
 - (b) in paragraph (15)(c)(ii), delete "or" at the end;
 - (c) in paragraph (15)(c), after sub-paragraph (ii), insert
 - "(iia) if the old vehicle was a specified Comfort or CityCab diesel taxi
 - (A) the old vehicle was not more than 8 years old; or
 - (B) the old vehicle was more than 8 years old, but the term of the certificate of entitlement that was renewed under rule 3 of the Road Traffic (Renewal of

Certificates of Entitlement for Specified Taxis) Rules 2024 (G.N. No. S 196/2024) or rule 3 of the Road Traffic (Renewal of Certificates of Entitlement for Specified Taxis) (No. 2) Rules 2024 (G.N. No. S 222/2024) in respect of the old vehicle had not expired;

- (iib) if the old vehicle was a specified hybrid taxi
 - (A) the old vehicle was not more than 8 years old; or
 - (B) the old vehicle was more than 8 years old, but the term of the certificate of entitlement that was renewed under rule 3 of the Traffic (Renewal Road Certificates of Entitlement for Specified Taxis) (No. 2) Rules 2024 or rule 3 of the Traffic (Renewal Road Certificates of Entitlement for Specified 3) Taxis) (No. 2024 Rules (G.N. No. S 368/2024) in respect of the old vehicle had not expired; or";
- (d) in paragraph (15A)(b)(i), after "a specified Comfort taxi", insert ", a specified Comfort or CityCab diesel taxi, a specified hybrid taxi";
- (e) in paragraph (15A)(b)(ii), delete "or" at the end;
- (f) in paragraph (15A)(b), after sub-paragraph (ii), insert —

- "(iia) if the old vehicle was a specified Comfort or CityCab diesel taxi
 - (A) the old vehicle was not more than 8 years old; or
 - (B) the old vehicle was more than 8 years old, but the term of the certificate of entitlement that was renewed under rule 3 of the (Renewal Road Traffic Certificates of Entitlement for Specified Taxis) Rules 2024 or rule 3 of the Road Traffic (Renewal of Certificates of Entitlement for Specified Taxis) (No. 2) Rules 2024 in respect of the old vehicle had not expired;
- (iib) if the old vehicle was a specified hybrid taxi
 - (A) the old vehicle was not more than 8 years old; or
 - (B) the old vehicle was more than 8 years old, but the term of the certificate of entitlement that was renewed under rule 3 of the Traffic (Renewal Road Certificates of Entitlement for Specified Taxis) (No. 2) Rules 2024 or rule 3 of the Traffic (Renewal Road Certificates of Entitlement for Taxis) Specified (No. Rules 2024 in respect of the old vehicle had not expired; or";

- (g) in paragraph (16), after the definition of "certificate of entitlement", insert
 - ""specified Comfort or CityCab diesel taxi" means a taxi specified in
 - (a) the Schedule to the Road Traffic (Renewal of Certificates of Entitlement for Specified Taxis) Rules 2024; or
 - (b) in Part 1 or 2 of the Schedule to the Road Traffic (Renewal of Certificates of Entitlement for Specified Taxis) (No. 2) Rules 2024;"; and
- (h) in paragraph (16), after the definition of "specified Comfort taxi", insert
 - ""specified hybrid taxi" means a taxi specified in
 - (a) Part 3, 4 or 5 of the Schedule to the Road Traffic (Renewal of Certificates of Entitlement for Specified Taxis) (No. 2) Rules 2024; or
 - (b) the Schedule to the Road Traffic (Renewal of Certificates of Entitlement for Specified Taxis) (No. 3) Rules 2024;".

Amendment of First Schedule

- **3.** In the Road Traffic (Motor Vehicles, Registration and Licensing) Rules, in the First Schedule, in Part IX
 - (a) in the heading "REBATE FOR DE-REGISTRATION OF OLD VEHICLES WHICH ARE TAXIS (OTHER THAN SPECIFIED COMFORT TAXIS OR SPECIFIED TAXIS)", after "SPECIFIED COMFORT TAXIS", insert ", SPECIFIED COMFORT OR CITYCAB DIESEL TAXIS, SPECIFIED HYBRID TAXIS";

(b) before the heading "REBATE FOR DE-REGISTRATION OF OLD VEHICLES WHICH ARE SPECIFIED TAXIS", insert —

"REBATE FOR DE-REGISTRATION OF OLD VEHICLES THAT ARE SPECIFIED COMFORT OR CITYCAB DIESEL TAXIS
