# COMMON GAMING HOUSES (EXEMPTION) (NO. 49) NOTIFICATION 2013

In exercise of the powers conferred by section 24 of the Common Gaming Houses Act, the Minister for Home Affairs hereby makes the following Notification:

## Citation

**1.** This Notification may be cited as the Common Gaming Houses (Exemption) (No. 49) Notification 2013.

#### Exemption

2.—(1) The Minister hereby exempts the Singapore Turf Club from the provisions of the Act in respect of the "Longines Singapore Gold Cup 2013 Race Against Time" promotion to be held from 2 p.m. on 14th October 2013 to 2 p.m. on 15th November 2013 and the draw to be held on 26th November 2013 at 5 p.m. at the Administration Building of the Singapore Racecourse.

(2) The exemption is subject to compliance by the Singapore Turf Club with the conditions specified in the Schedule.

#### THE SCHEDULE

Paragraph 2

### CONDITIONS

- 1. The methodology of the promotion, the details of the prizes to be distributed, their manner of distribution and, if the winners are determined solely or partly by a draw, the time, date and place of the draw, shall be disclosed in printed publicity material, copies of which shall be freely available to all participants.
- 2. The draw shall be conducted by the Singapore Turf Club and its officers only.
- 3. Any draw by means of a computerised system which is not conducted in public shall be witnessed and audited by a public accountant who is not in the employment of the Singapore Turf Club.
- 4. The draw shall not involve the use of any game, method, device, scheme or competition declared by the Minister in a notification under section 2(3) of the Act.
- 5. The draw shall not involve the use of any instrument or appliance for gaming declared by the Minister in a notification under section 2(4) of the Act.
- 6. The Singapore Turf Club shall undertake to ensure that
  - (a) the results of the draw will be published on the Singapore Turf Club Facebook Fan Page and the Longines Singapore Gold Cup website; and
  - (b) an audited statement of accounts shall, together with the results of the draw, be sent by registered post to the Head, Specialised Crime Policy Branch, Criminal Investigation Department, no later than 27th February 2014.
