## ENERGY CONSERVATION ACT (CHAPTER 92C)

# ENERGY CONSERVATION (FUEL ECONOMY AND VEHICULAR EMISSIONS LABELLING) (AMENDMENT) REGULATIONS 2020

In exercise of the powers conferred by section 62 of the Energy Conservation Act, the Minister for Transport makes the following Regulations:

### Citation and commencement

**1.** These Regulations are the Energy Conservation (Fuel Economy and Vehicular Emissions Labelling) (Amendment) Regulations 2020 and come into operation on 1 August 2020.

### Amendment of regulation 2

**2.** Regulation 2(1) of the Energy Conservation (Fuel Economy and Vehicular Emissions Labelling) Regulations 2012 (G.N. No. S 307/2012) is amended —

- (*a*) by inserting, immediately before the definition of "Commission Regulation (EU) No. 2017/1152", the following definition:
  - ""Commission Regulation (EU) No. 2017/1151" Regulation means the Commission (EU) 2017/1151 of 1 June 2017 supplementing Regulation No. 715/2007 of the European (EC) Parliament and of the Council on type-approval of motor vehicles with respect to emissions from light passenger and commercial vehicles (Euro 5 and Euro 6)

and on access to vehicle repair and maintenance information, amending Directive 2007/46/EC of the European Parliament and of the Council, Commission Regulation (EC) No. 692/2008 and Commission Regulation (EU) No. 1230/2012 and repealing Commission Regulation (EC) No. 692/2008;"; and

- (b) by deleting the full-stop at the end of the definition of "vehicular emissions label" and substituting a semi-colon, and by inserting immediately thereafter the following definition:
  - ""WLTP Japan" means the provisions set out in TRIAS 08-002-02 and the provisions in **"WLTC-MODE** METHOD" of the attachment of "Measurement Procedure for Exhaust Emission of Light- and Medium-Duty Motor Vehicles, II. WLTC-mode Method" (otherwise known as Part Π of Attachment 42) of the Japanese Ministry of Land. Infrastructure and Transport Announcement No. 619 dated 15 July 2002 (ANNOUNCEMENT THAT PRESCRIBES DETAILS OF SAFETY REGULATIONS FOR ROAD VEHICLES).".

#### Amendment of regulation 3

**3.** Regulation 3(2) of the Energy Conservation (Fuel Economy and Vehicular Emissions Labelling) Regulations 2012 is amended —

(a) by deleting the words "or EC Directive 80/1268/EEC" in sub-paragraph (b)(i)(A) and substituting the words ", EC Directive 80/1268/EEC, Commission Regulation (EU) No. 2017/1151 or WLTP Japan"; and

(b) by deleting the words "or EC Directive 80/1268/EEC," in sub-paragraph (b)(ii)(A) and substituting the words ", EC Directive 80/1268/EEC, Commission Regulation (EU) No. 2017/1151 or WLTP Japan,".
