Citation and commencement

1. This Order is the Housing and Development (Precincts for Upgrading Works) (Home Improvement Programme) (No. 2) Order 2021 and comes into operation on 1 September 2021.

Declaration of precincts for Home Improvement Programme

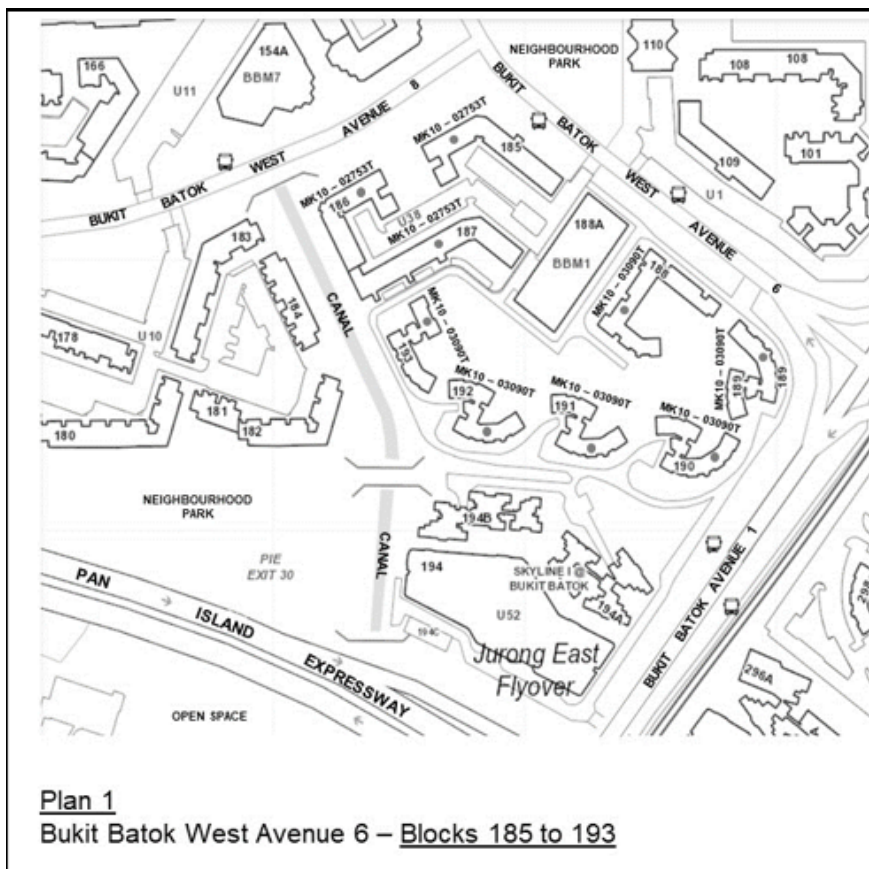
2. The parts of the housing estates of the Board described in the Schedule are declared to be precincts for the purpose of carrying out upgrading works in connection with the Home Improvement Programme.

All that part of the housing estate of the Board bounded by Bukit Batok West Avenue 8, Bukit Batok West Avenue 6 and Bukit Batok Avenue 1, comprised in Lot number 02753T in Mukim 10 and on which Apartment Blocks 185, 186 and 187 are erected, and in Lot number 03090T in Mukim 10 and on which Apartment Blocks 188, 189, 190, 191, 192 and 193 are erected, and which is more particularly edged in Plan 1.

BUKIT BATOK WEST AVENUE 6

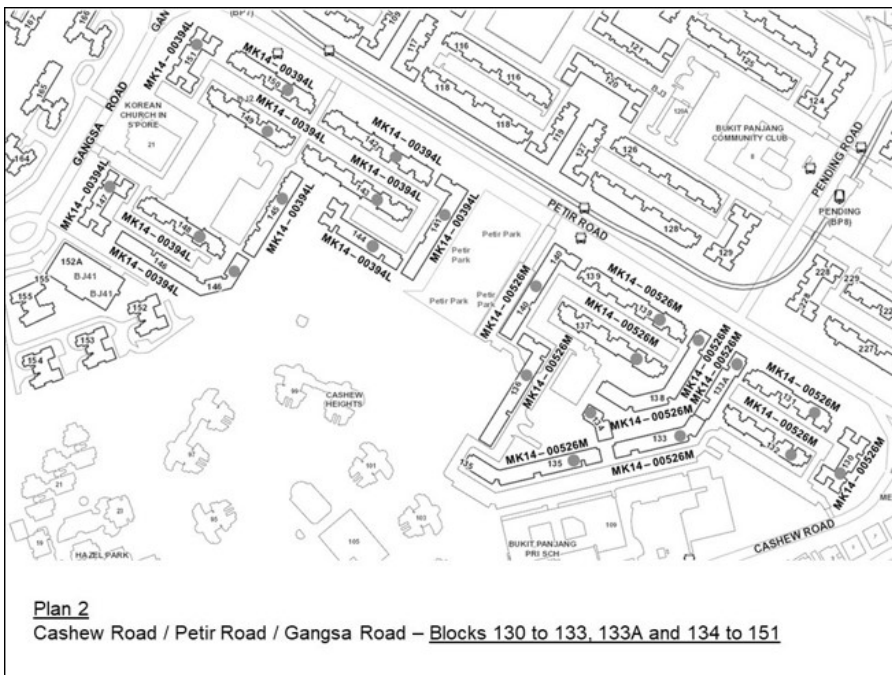

CASHEW ROAD / PETIR ROAD / GANGSA ROAD

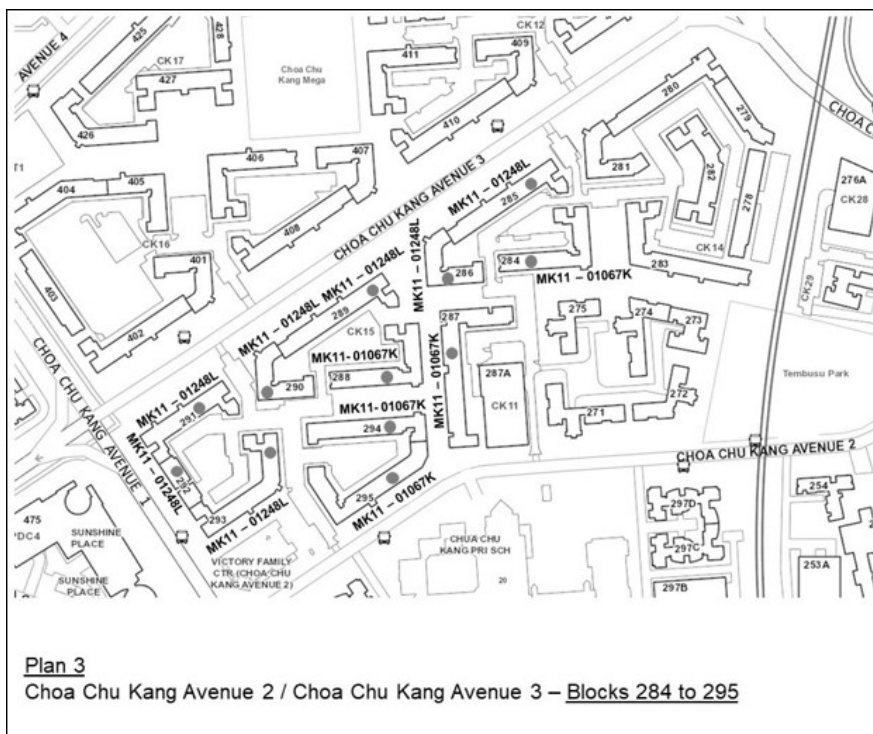

CHOA CHU KANG AVENUE 2 / CHOA CHU KANG AVENUE 3

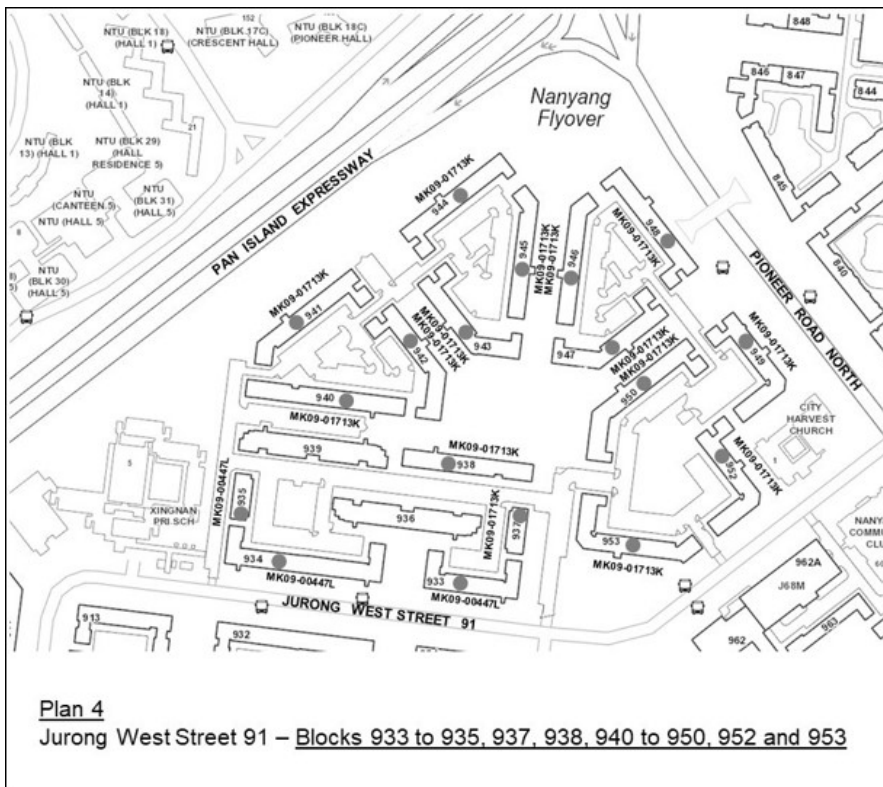

JURONG WEST STREET 91

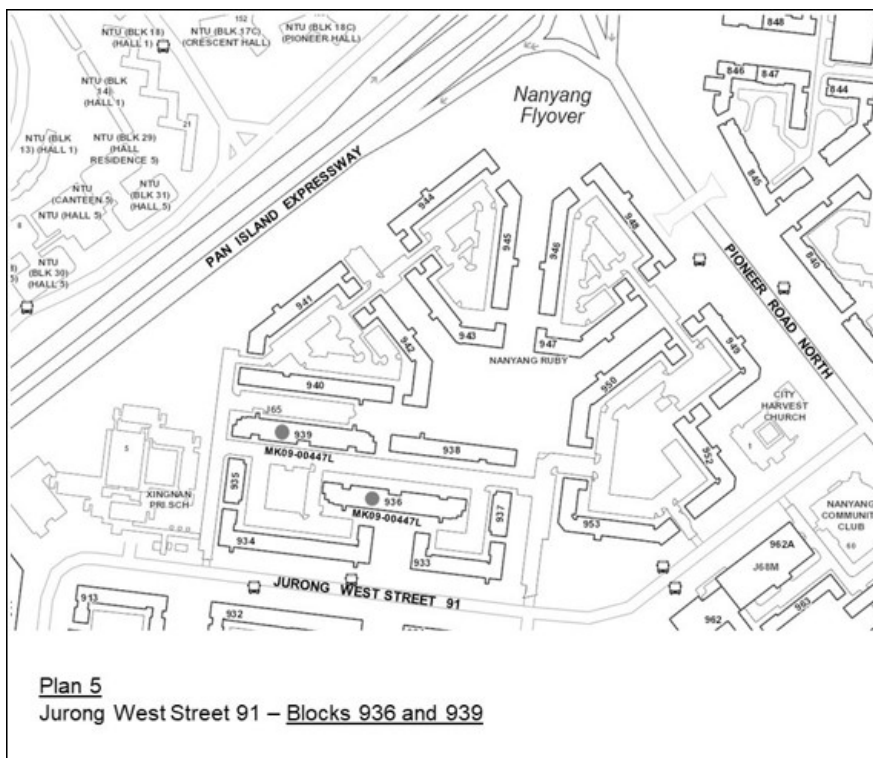

JURONG WEST STREET 91

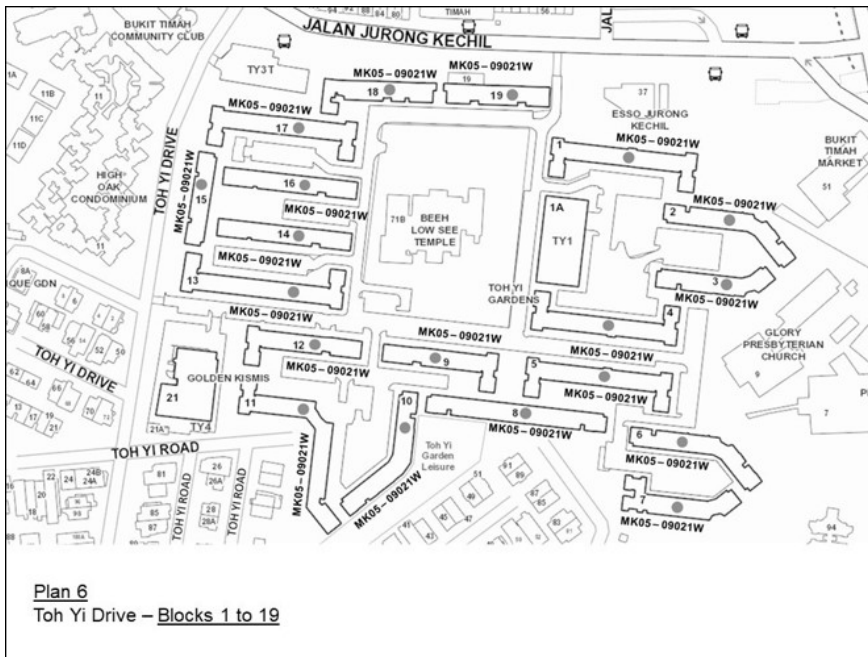
