## Citation and commencement

1. This Order is the Income Tax (Singapore — Ireland) (Avoidance of Double Taxation Agreement) (Modifications to Implement Multilateral Instrument) (Amendment) Order 2020 and is deemed to have come into operation on 1 May 2019.

## **Amendment of Schedule**

**2.** Article 25A in paragraph 4 of the Schedule to the Income Tax (Singapore — Ireland) (Avoidance of Double Taxation Agreement) (Modifications to Implement Multilateral Instrument) Order 2019 (G.N. No. S 357/2019) is amended by inserting, immediately after the words "sub-paragraph (c)" in paragraph 12(b), the words "or (d)".
