In exercise of the powers conferred by sections 14(1) and 19(1) of the Infrastructure Protection Act 2017, the Minister for Home Affairs makes the following Order:

#### **Citation and commencement**

1. This Order is the Infrastructure Protection (Protected Places) (No. 17) Order 2024 and comes into operation on 19 August 2024.

#### **Premises declared to be protected place**

2. The premises described in the second column of the Schedule are declared to be a protected place for the purposes of the Act, and the person specified in the first column of that Schedule is designated as the authority of the protected place.

#### **Revocation**

3. Revoke the Protected Places (No. 5) Order 2014 (G.N. No. S 479/2014).

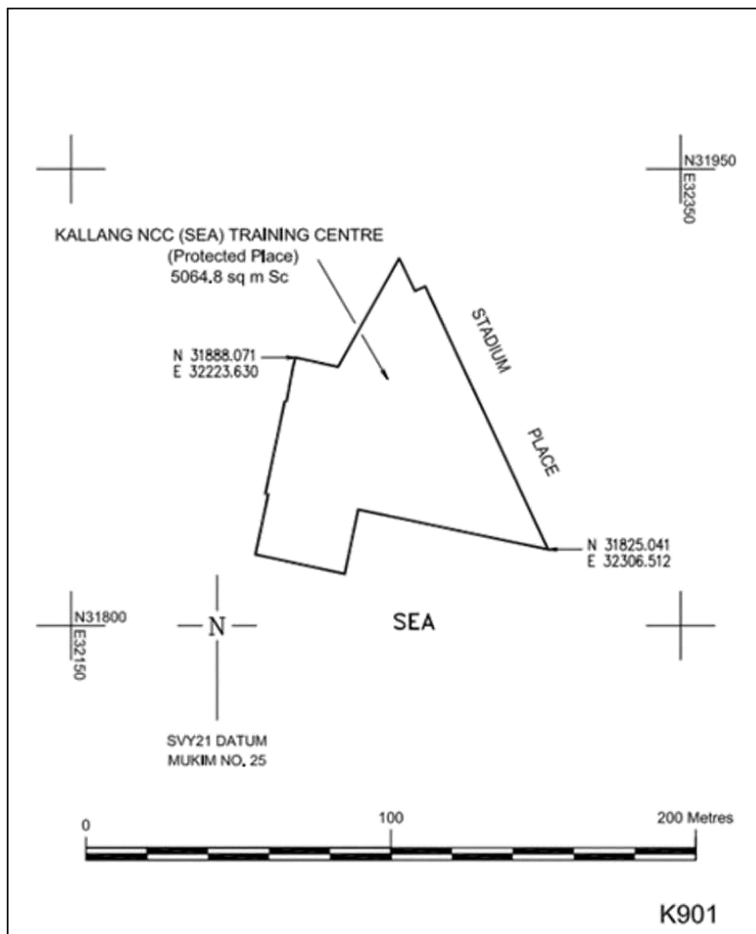
