ACTIVE MOBILITY ACT 2017

ACTIVE MOBILITY (SHARED PATHS) (AMENDMENT NO. 3) ORDER 2024

In exercise of the powers conferred by section 6 of the Active Mobility Act 2017, the Land Transport Authority of Singapore makes the following Order:

Citation and commencement

1. This Order is the Active Mobility (Shared Paths) (Amendment No. 3) Order 2024 and comes into operation on 25 August 2024.

Amendment of First Schedule

- **2.** In the Active Mobility (Shared Paths) Order 2018 (G.N. No. S 260/2018), in the First Schedule
 - (a) in Part 1, replace item 21 with
 - "21. A path (approximately 0.46 kilometre in length) starting at the junction of Ang Mo Kio Avenue 2 and Ang Mo Kio Street 13, running along Ang Mo Kio Street 13 and ending at the junction of Ang Mo Kio Street 13 and Ang Mo Kio Avenue 4.";
 - (b) in Part 1, after item 51, insert
