### CONSTITUTION OF THE REPUBLIC OF SINGAPORE (RESPONSIBILITY OF THE MINISTER FOR NATIONAL DEVELOPMENT) NOTIFICATION 2015

#### **Responsibility of Minister for National Development**

It is notified for general information that the Prime Minister has, under Article 30(1) of the Constitution of the Republic of Singapore, directed that with effect from 1 October 2015, Mr Lawrence Wong is charged with the responsibility for the departments and subjects set out in the Schedule and designated as the Minister for National Development.

#### **Citation**

2. This Notification may be cited as the Constitution of the Republic of Singapore (Responsibility of the Minister for National Development) Notification 2015.

#### **Cancellation**
