**Citation and commencement**

1. This Order is the Housing and Development (Precincts for Upgrading Works) (Home Improvement Programme) (No. 10) Order 2019 and comes into operation on 11 October 2019.

**Declaration of precincts for Home Improvement Programme**

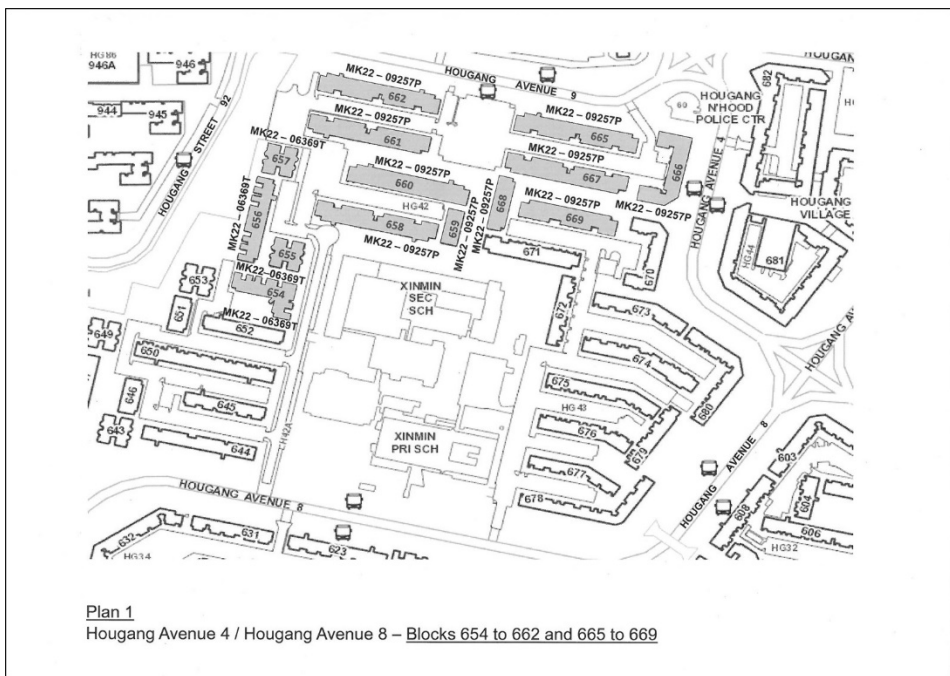
2. The parts of the housing estates of the Board described in the Schedule are declared to be precincts for the purpose of carrying out upgrading works in connection with the Home Improvement Programme.

## THE SCHEDULE

1. All that part of the housing estate of the Board bounded by Hougang Avenue 8, Hougang Street 92, Hougang Avenue 9 and Hougang Avenue 4, comprised in Lot number 06369T in Mukim 22 and on which Apartment Blocks 654, 655, 656 and 657 are erected, and in Lot number 09257P in Mukim 22 and on which Apartment Blocks 658, 659, 660, 661, 662, 665, 666, 667, 668 and 669 are erected, and which is more particularly shaded in Plan 1.

## HOUGANG AVENUE 4/HOUGANG AVENUE 8

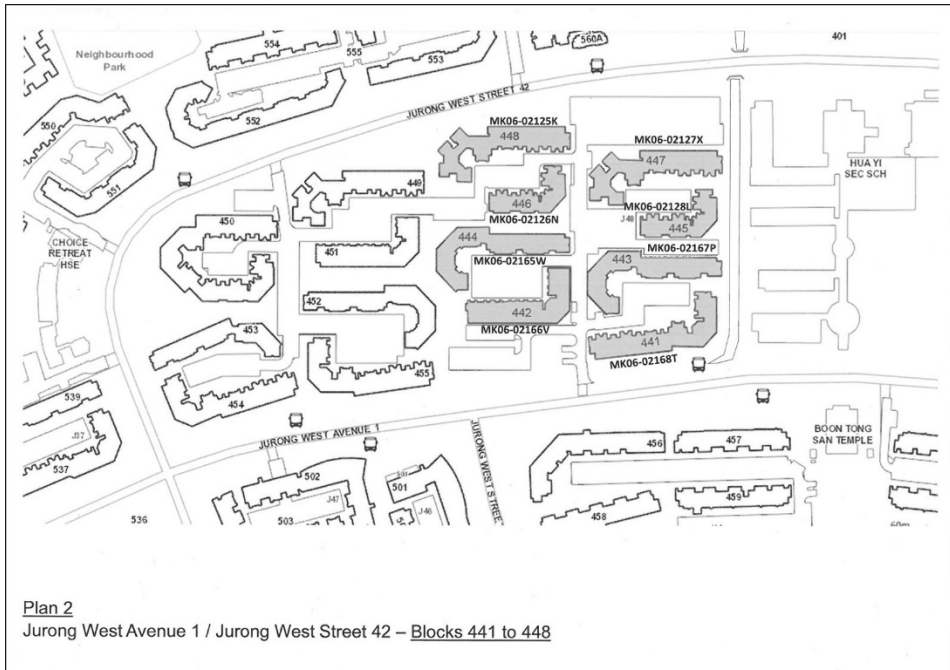

## JURONG WEST AVENUE 1/JURONG WEST STREET 42

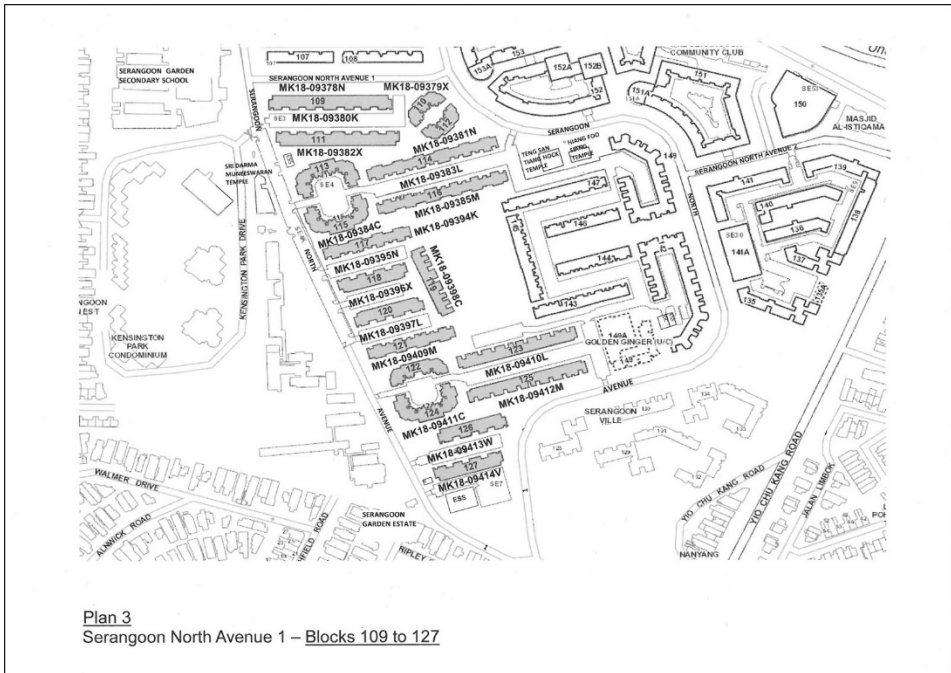

SERANGOON NORTH AVENUE 1



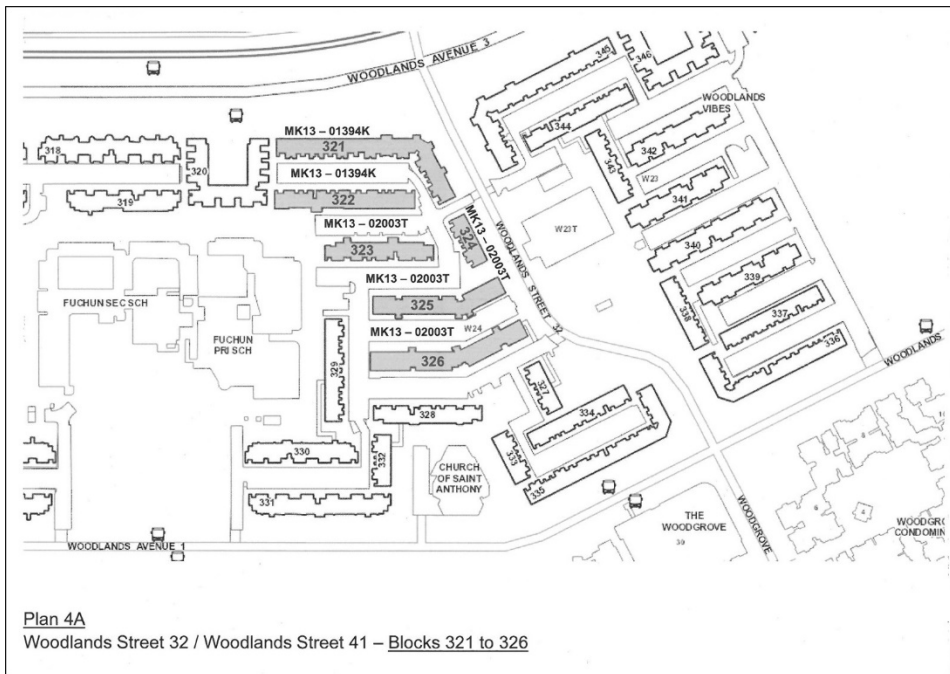

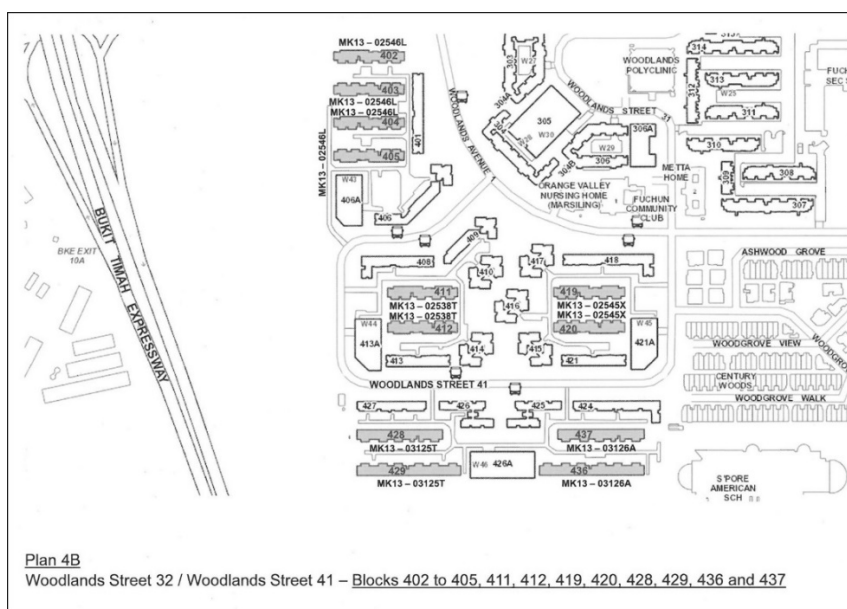
