COMMON GAMING HOUSES (EXEMPTION) (NO. 67) NOTIFICATION 2014

ARRANGEMENT OF PARAGRAPHS

In exercise of the powers conferred by section 24 of the Common Gaming Houses Act, the Minister for Home Affairs hereby makes the following Notification:

Citation

1. This Notification may be cited as the Common Gaming Houses (Exemption) (No. 67) Notification 2014.

Exemption

- **2.**—(1) The Minister hereby exempts Resorts World at Sentosa Pte. Ltd. from the provisions of the Act in respect of
 - (a) the "RWS Promotional Games (Revised 1) RWS ETG Sprint 2014" promotion to be held from 8 October 2014 to 12 October 2014 (both dates inclusive);
 - (b) the "Daily Sprint" games to be held within the premises of the Casino of Resorts World at Sentosa Pte. Ltd. as part of that promotion between 9 a.m. to 9 p.m. from 8 October 2014 to 11 October 2014 (both dates inclusive);

- (c) the "Final Sprint" games to be held within the premises of the Casino of Resorts World at Sentosa Pte. Ltd. as part of that promotion from 12 noon to 6 p.m. on 12 October 2014; and
- (d) the "Grand Draw" to be held at the Casino Royale Bar (Level B1) of Resorts World at Sentosa Pte. Ltd. as part of that promotion from 8.30 p.m. to 9 p.m. on 12 October 2014.
- (2) The exemption is subject to compliance by Resorts World at Sentosa Pte. Ltd. with the conditions specified in the Schedule.

THE SCHEDULE

Paragraph 2

CONDITIONS

- 1. The methodology of the promotion, the details of the prizes to be distributed, their manner of distribution and, if the winners are determined solely or partly by a draw, the time, date and place of the draw, must be disclosed in printed publicity material, copies of which must be freely available to all participants.
- 2. Every draw must be conducted by persons in the employment of Resorts World at Sentosa Pte. Ltd. only.
- 3. Every draw must be conducted in public.
- 4. Every draw by means of a computerised system which is not conducted in public must be witnessed and audited by a public accountant who is not in the employment of Resorts World at Sentosa Pte. Ltd.
- 5. Every draw must not involve the use of any game, method, device, scheme or competition declared by the Minister in a notification under section 2(3) of the Act.
- 6. Every draw must not involve the use of any instrument or appliance for gaming declared by the Minister in a notification under section 2(4) of the Act.
- 7. The results of the draw must be displayed on the casino's plasma television sets after each draw is completed.
- 8. Resorts World at Sentosa Pte. Ltd. must, before the start of the draw, undertake to ensure that an audited statement of accounts, together with the results of the draws, be sent by registered post to the Head, Specialised Crime Policy Branch, Criminal Investigation Department, no later than 13 January 2015.
