CRIMINAL PROCEDURE CODE  
(PRESCRIBED FORMS) (AMENDMENT)  
REGULATIONS 2012

In exercise of the powers conferred by section 428(2) of the Criminal Procedure Code, the Minister for Law hereby makes the following Regulations:

**Citation and commencement**

1. These Regulations may be cited as the Criminal Procedure Code (Prescribed Forms) (Amendment) Regulations 2012 and shall come into operation on 2nd January 2013.

**Amendment of Schedule**

2. The Schedule to the Criminal Procedure Code (Prescribed Forms) Regulations 2010 (G.N. No. S 811/2010) is amended —

(a) by deleting Form 56 and substituting the following Form:

WARRANT OF EXECUTION ON A SENTENCE OF DEATH  
(SECTION 313(g))

To: The Director of Prisons.
