**ROAD TRAFFIC ACT
(CHAPTER 276)**

**RESTRICTION OF SPEED (ROADS) (AMENDMENT NO. 5)
NOTIFICATION 2005**

In exercise of the powers conferred by section 63(2) of the Road Traffic Act, the Minister for Home Affairs hereby makes the following Notification:

Citation and commencement

1. This Notification may be cited as the Restriction of Speed (Roads) (Amendment No. 5) Notification 2005 and shall come into operation on 1st November 2005.

Amendment of Second Schedule

2. The Second Schedule to the Restriction of Speed (Roads) Notification (N 6) is amended —

(d) by inserting, immediately below the item relating to “Canberra Road”, the following items:

“Cantonment Link.

“Chin Swee Road.”;

(r) by inserting, immediately below the item relating to “Marine Parade Road”, the following item:

“Merchant Road.”;

(s) by inserting, immediately below the item relating to “Mountbatten Road”, the following items:

“Napier Road.

New Bridge Road.”;

(t) by inserting, immediately below the item relating to “New Upper Changi Road”, the following items:

“Newton Road.

- (z) by inserting, immediately below the item relating to “Tampines Street 31”, the following item:

“Telok Blangah Road.”;

- (za) by inserting, immediately below the item relating to “Thomson Road”, the following item:

“Tiong Bahru Road — that part of Tiong Bahru Road between Outram Road and Zion Road.”;

- (zb) by deleting the item relating to “Ulu Pandan Road”;

(zc) by inserting, immediately below the item relating to “Upper Thomson Road”, the following item:

“Victoria Street.”; and

(zd) by inserting, immediately below the item relating to “Yishun Avenue 7”, the following item:

“Zion Road.”.

Amendment of Third Schedule

3. The Third Schedule to the Restriction of Speed (Roads) Notification is amended —

(a) by deleting the item relating to “Commonwealth Avenue West” and substituting the following item:

“Commonwealth Avenue West — that part of Commonwealth Avenue West between Clementi Road and North Buona Vista Road.”;

(b) by inserting, immediately below the item relating to “Dunearn Road”, the following item:

“Esplanade Drive.”;

(c) by inserting, immediately below the item relating to “Gambas Avenue”, the following item:

“Holland Road — that part of Holland Road —

(a) between Ulu Pandan Road and Holland Grove Road; and

(b) between Farrer Road and Napier Road.”;

(d) by inserting, immediately below the item relating to “Jurong West Avenue 4”, the following item:

“Keppel Road — that part of Keppel Road between Telok Blangah Road and lamp post No. 8.”;

(e) by deleting the item relating to “Nicoll Highway” and substituting the following items:

“Nicoll Highway.

North Buona Vista Road — that part of North Buona Vista Road between Commonwealth Avenue and South Buona Vista Road.”;

(f) by inserting, immediately below the item relating to “Pioneer Road”, the following item:

“Portstown Avenue.”;

(g) by inserting, immediately below the item relating to “Punggol East”, the following item:

“Queensway — that part of Queensway between Farrer Road and Portstown Avenue.”; and

(h) by inserting, immediately below the item relating to “Turf Club Avenue”, the following item:

“Ulu Pandan Road.”.
