In exercise of the powers conferred by section 65B(1) of the Housing and Development Act, the Minister for National Development, after consulting the Housing and Development Board, hereby makes the following Order:

Citation and commencement

1. This Order may be cited as the Housing and Development (Precincts for Upgrading Works) (Home Improvement Programme) (No. 8) Order 2014 and shall come into operation on 15 October 2014.

Declaration of precincts for Home Improvement Programme

2. The parts of the housing estates of the Board described in the Schedule are hereby declared to be precincts for the purpose of carrying out upgrading works in connection with the Home Improvement Programme.

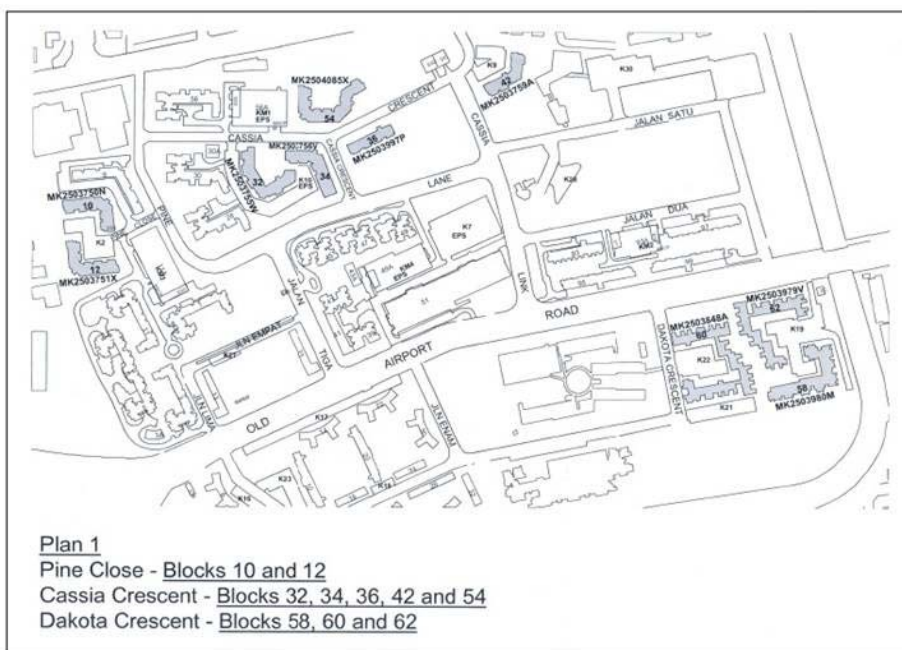

and 12 are erected, and at Cassia Crescent, comprised in Lot numbers 03755W, 03756V, 03997P, 03759A and 04085X in Mukim 25 and on which Apartment Blocks 32, 34, 36, 42 and 54 are erected, and at Dakota Crescent, comprised in Lot numbers 03980M, 03848A and 03979V in Mukim 25 and on which Apartment Blocks 58, 60 and 62 are erected, and which is more particularly shaded in Plan 1.

PLAN 1

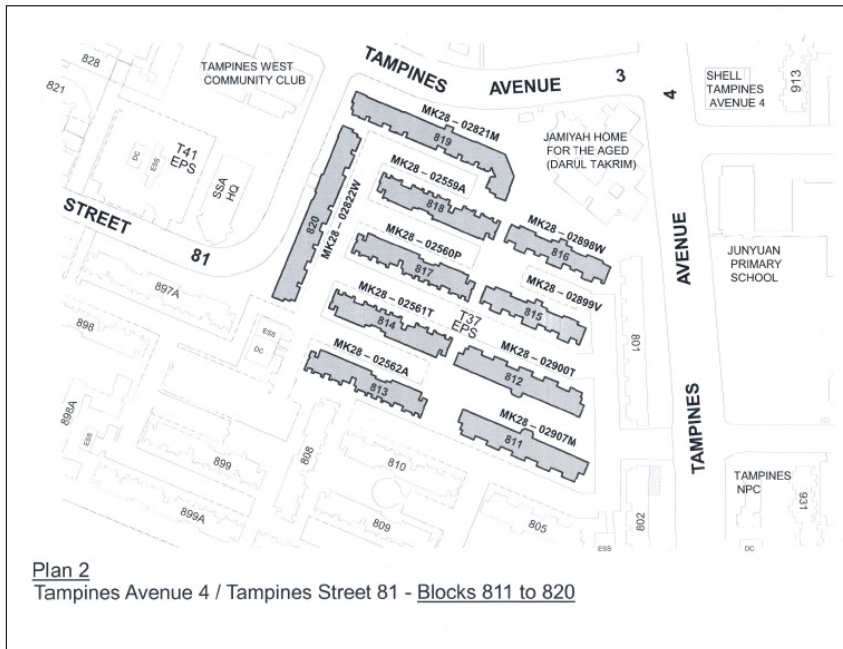
PINE CLOSE/CASSIA CRESCENT/DAKOTA CRESCENT
