**ROAD TRAFFIC  
(ELECTRONIC ROAD PRICING SYSTEM)  
(AMENDMENT) RULES 2024**

In exercise of the powers conferred by section 34D of the Road Traffic Act 1961, the Minister for Transport makes the following Rules:

**Citation and commencement**

1. These Rules are the Road Traffic (Electronic Road Pricing System) (Amendment) Rules 2024 and come into operation on 9 September 2024.

**Amendment of First Schedule**

2. In the Road Traffic (Electronic Road Pricing System) Rules 2015 (G.N. No. S 226/2015), in the First Schedule —
