**CENTRAL PROVIDENT FUND ACT
(CHAPTER 36)**

**CENTRAL PROVIDENT FUND
(APPROVED HDB-HUDC HOUSING SCHEME)
(AMENDMENT) REGULATIONS 2013**

In exercise of the powers conferred by section 77(1) of the Central Provident Fund Act, Mr Tan Chuan-Jin, Senior Minister of State, charged with the responsibility of the Minister for Manpower, after consulting with the Central Provident Fund Board, hereby makes the following Regulations:

Citation and commencement

1. These Regulations may be cited as the Central Provident Fund (Approved HDB-HUDC Housing Scheme) (Amendment) Regulations 2013 and shall come into operation on 15th December 2013.

New regulation 15A

2. The Central Provident Fund (Approved HDB-HUDC Housing Scheme) Regulations (Rg 14) are amended by inserting, immediately after regulation 15, the following regulation:

“Application for cancellation of charge on immovable property

15A.—(1) For the purposes of sections 21(10A), 21A(9A) and 27E(2)(ii) of the Act, where there is a charge under section 21(1) or 21A(1) of the Act, as the case may be, on a member’s estate or interest in an immovable property, the member may apply to the Board for the charge to be cancelled.

(2) The Board may approve an application under paragraph (1) for the charge to be cancelled if the Board is satisfied that the member —

- (a) is entitled to withdraw the amount standing to his credit in the Fund under section 15(2)(a), (d), (e), (f) or (g), (3), (4), (7A) or (8) of the Act;
 - (b) has complied with the requirements in section 15(2A), (6), (7B) or (8A) of the Act, as the case may be; and
 - (c) has complied with such terms and conditions as the Board may impose.”.

Amendment of regulation 16

3. Regulation 16 of the Central Provident Fund (Approved HDB-HUDC Housing Scheme) Regulations is amended —

- (a) by deleting the words “for the withdrawal of moneys” in paragraph (1); and
- (b) by deleting the regulation heading and substituting the following regulation heading:

“Manner of application”.
