In exercise of the powers conferred by section 65B(1) of the Housing and Development Act, the Minister for National Development, after consulting the Housing and Development Board, hereby makes the following Order:

Citation and commencement

1. This Order may be cited as the Housing and Development (Precincts for Upgrading Works) (Home Improvement Programme) (No. 7) Order 2013 and shall come into operation on 18th December 2013.

Declaration of precincts for Home Improvement Programme


2. The parts of the housing estates of the Board described in the Schedule are hereby declared to be precincts for the purpose of carrying out upgrading works in connection with the Home Improvement Programme.

THE SCHEDULE

1. All that part of the housing estate of the Board at Aljunied Crescent comprised in Lot numbers 05375M, 05376W, 05379T, 05380V, 05382T and 05383A in Mukim 24 and on which Apartment Blocks 99, 101, 102, 104, 105 and 106 are erected, and in Lot number 09611P in Mukim 24 and on which Apartment Blocks 100 and 103 are erected, and which is more particularly shaded in Plan 1.

ALJUNIED CRESCENT



BEDOK NORTH AVENUE 3/STREET 2


