(CHAPTER 256)

PROTECTED PLACES
(CONSOLIDATION) (AMENDMENT NO. 6)
ORDER 2014

In exercise of the powers conferred by section 5(1) of the Protected Areas and Protected Places Act, the Minister for Home Affairs hereby makes the following Order:

Citation and commencement

1. This Order may be cited as the Protected Places (Consolidation) (Amendment No. 6) Order 2014 and shall come into operation on 18 November 2014.

Amendment of Schedule

2. The Schedule to the Protected Places (Consolidation) Order (O 2) is amended —

- (a) by deleting the words “situated with a 50-yard frontage in Hill Street near the junction of Stamford Road, bounded by a passage way between the Telephone House and Central Exchange on the north side, and a perimeter wall between Lee Kim Soo Ltd. Store and the Exchange on the east side by” in paragraph 1 of item (1) and substituting the words “comprised in Lot 9K, TS10 containing an area of approximately 2,324.5 square metres and Lot 99, TS10 containing an area of approximately 1,367.3 square metres and bounded by Hill Street at the front, separated by a perimeter wall facing Stamford House to the right, another perimeter wall facing Burhani Mosque to the left and”;
- (b) by deleting paragraph 9 of item (1) relating to Bukit Timah Exchange, Holland Road; and

(c) by deleting item (3) relating to Civil Radio Receiving Station,
Yio Chu Kang.
