In exercise of the powers conferred by section 65B(1) of the Housing and Development Act, the Minister for National Development, after consulting the Housing and Development Board, makes the following Order:

**Citation and commencement**

1. This Order may be cited as the Housing and Development (Precincts for Upgrading Works) (Home Improvement Programme) (No. 10) Order 2015 and comes into operation on 23 December 2015.

**Declaration of precincts for Home Improvement Programme**

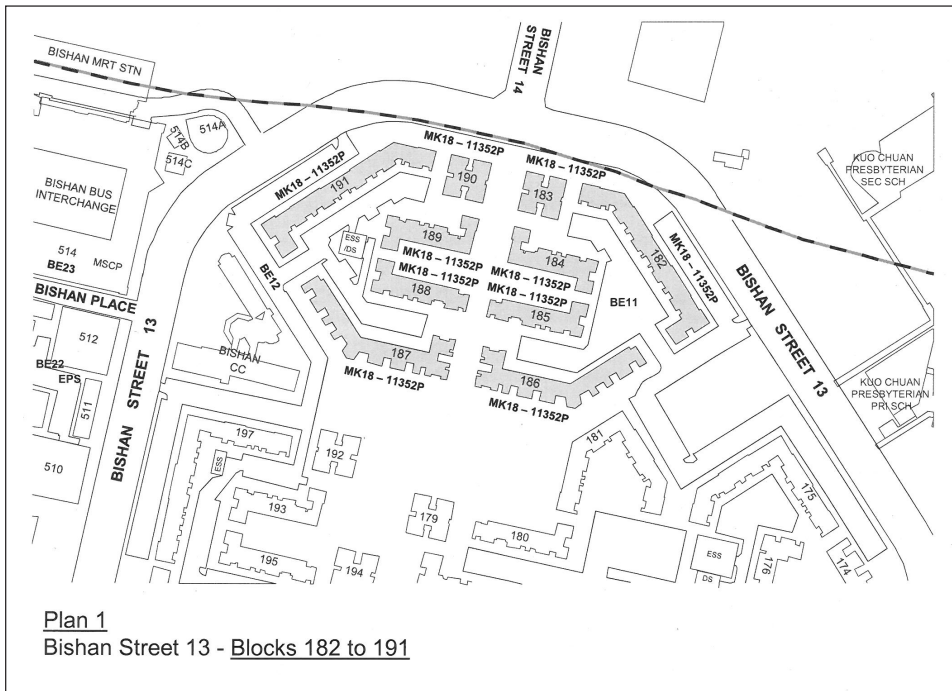
2. The parts of the housing estates of the Board described in the Schedule are declared to be precincts for the purpose of carrying out upgrading works in connection with the Home Improvement Programme.

THE SCHEDULE

1. All that part of the housing estate of the Board at Bishan Street 13, comprised in Lot number 11352P in Mukim 18 and on which Apartment Blocks 182, 183, 184, 185, 186, 187, 188, 189, 190 and 191 are erected, and which is more particularly shaded in Plan 1.

BISHAN STREET 13

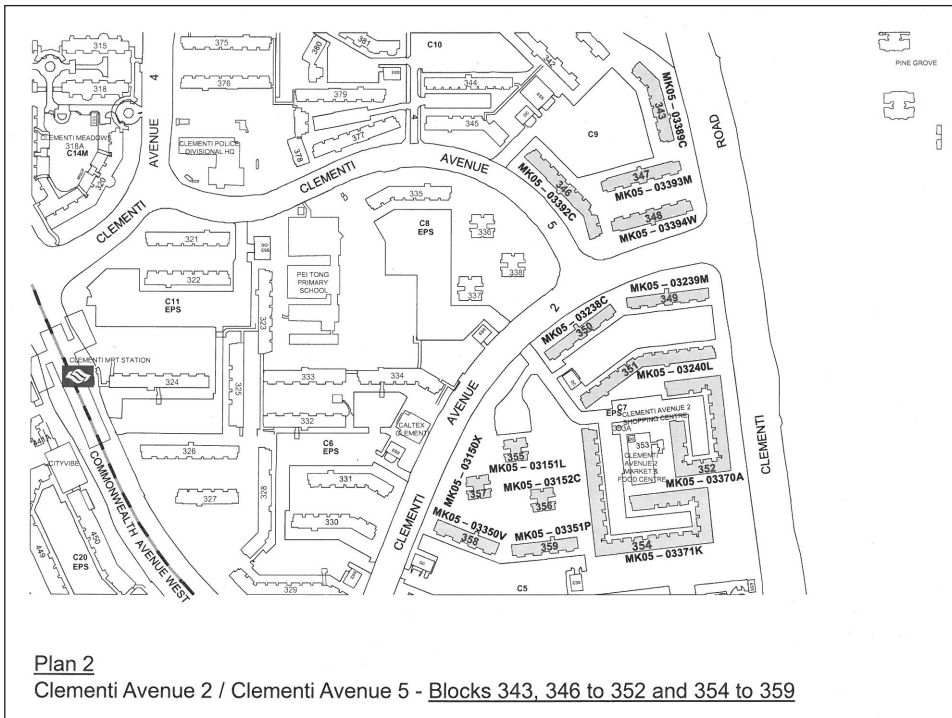

CLEMENTI AVENUE 2/CLEMENTI AVENUE 5

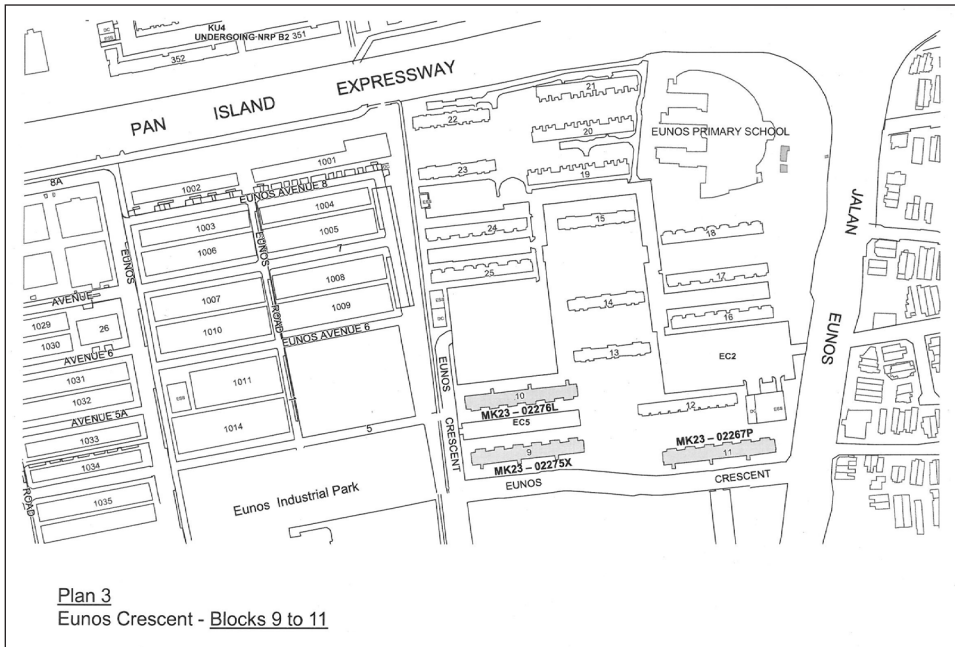

EUNUS CRESCENT

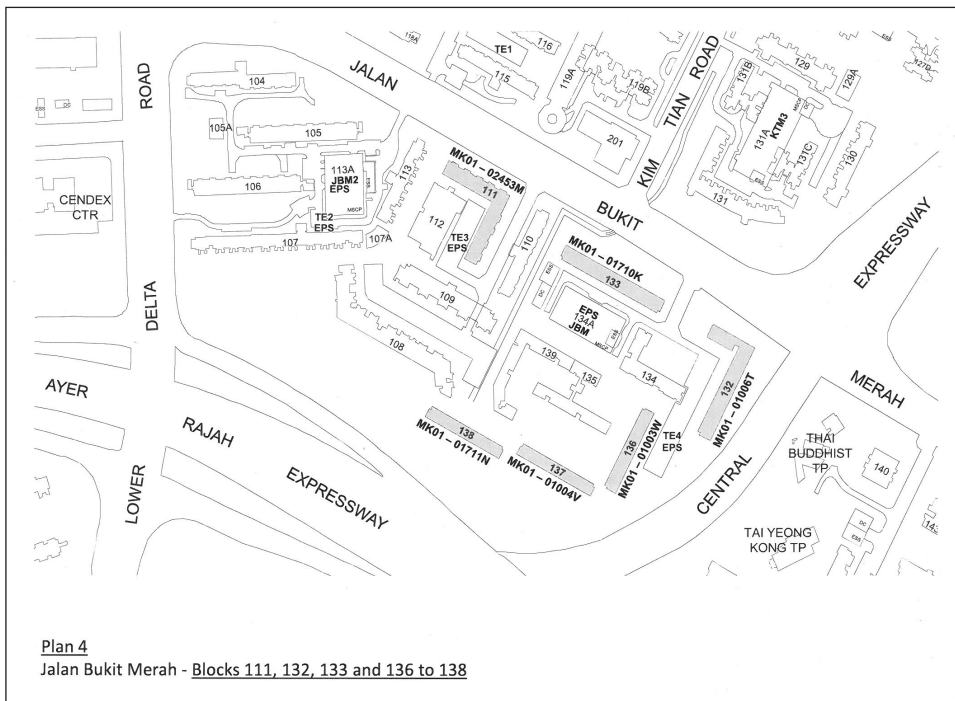

JALAN BUKIT MERAH

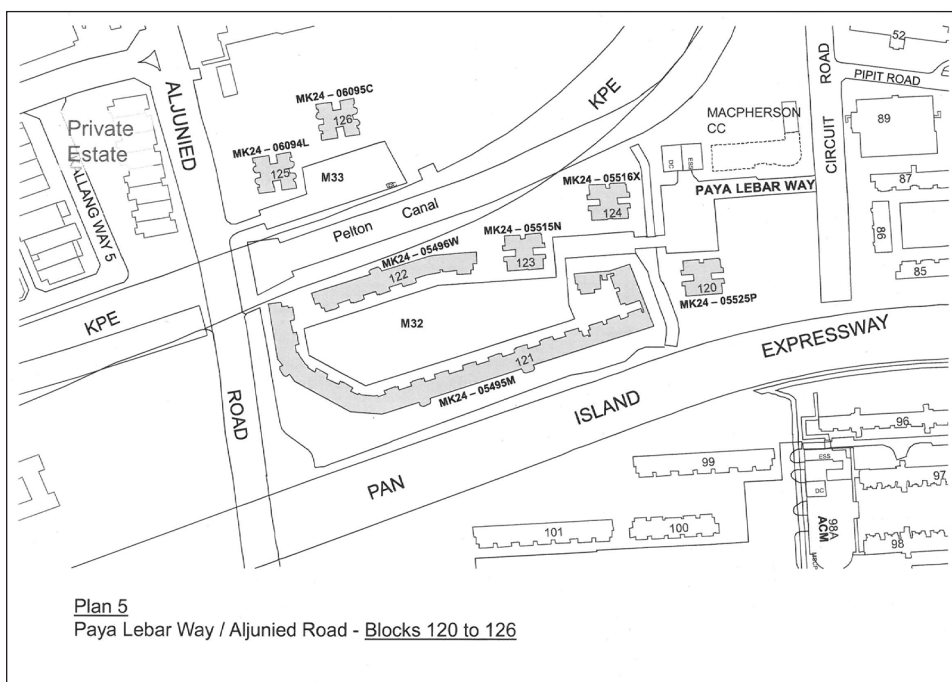
