REMOTE GAMBLING (HEALTH PROMOTION BOARD — EXEMPTION) (NO. 3) ORDER 2022

In exercise of the powers conferred by section 40 of the Remote Gambling Act 2014, the Minister for Home Affairs makes the following Order:

Citation

1. This Order is the Remote Gambling (Health Promotion Board — Exemption) (No. 3) Order 2022.

Definitions

2. In this Order, unless the context otherwise requires —

“draw” means the draw to be held as part of the promotion at 3 Second Hospital Avenue, Singapore 168937 from 8.30 a.m. to 6 p.m. on 31 March 2022;

“organiser” means the Health Promotion Board established by section 3 of the Health Promotion Board Act 2001;

“promotion” means the promotion called “Love at First MOVE Challenge with Fave and Swensen’s” that is to be made available from 14 February 2022 to 27 February 2022 (both

dates inclusive) on the Healthy 365 mobile application platform maintained by the organiser;

“public accountant” has the meaning given by section 2(1) of the Accountants Act 2004.

Exemptions

3.—(1) The organiser is exempt from sections 11, 13, 15 and 17 of the Act in respect of the promotion and the draw.

(2) The organiser is exempt from sections 13, 15 and 17 of the Act from 7 February 2022 to 13 February 2022 (both dates inclusive) in respect of any prohibited act under any of those sections carried out for the purposes of the promotion and the draw.

(3) The exemption is subject to compliance by the organiser with the conditions specified in the Schedule.

THE SCHEDULE

Paragraph 3(3)

CONDITIONS

1. All the following details must be included in publicity material that must be freely accessible to every participant of the draw:
 - (a) the name and address of the organiser;
 - (b) the details of the prizes to be distributed;
 - (c) the manner in which the prizes will be distributed;
 - (d) the time, date and place of the draw;
 - (e) how a person may participate in the draw;
 - (f) the manner in which the draw is to be conducted.
2. The organiser must keep a record of the name and email address or contact number of every participant of the draw.
3. Only persons in the employment of the organiser may conduct the draw.
4. The draw must —
 - (a) be conducted in public; or

- (b) if conducted in private by means of a computerised system, be witnessed and audited by a public accountant who is not in the employment of the organiser.
5. The organiser must undertake to ensure that every winner is notified through the Healthy 365 mobile application, SMS, telephone or email.
6. The organiser must, before the start of the draw, undertake to ensure that an audited statement of accounts and the results of the draw are sent by registered post to the Head, Specialised Crime Policy Branch, Criminal Investigation Department, Singapore Police Force, no later than 1 July 2022.
