### **ACTIVE MOBILITY ACT 2017**

# ACTIVE MOBILITY (SHARED PATHS) (AMENDMENT NO. 4) ORDER 2023

In exercise of the powers conferred by section 6 of the Active Mobility Act 2017, the Land Transport Authority of Singapore makes the following Order:

### **Citation and commencement**

**1.** This Order is the Active Mobility (Shared Paths) (Amendment No. 4) Order 2023 and comes into operation on 1 December 2023.

#### **Amendment of First Schedule**

**2.**—(1) In the Active Mobility (Shared Paths) Order 2018 (G.N. No. S 260/2018) (called in this Order the principal Order), in the First Schedule, in Part 2, after item 57, insert —

"58. A path (approximately 0.15 kilometre in length) starting at the junction of Jalan Eunos and Bedok Reservoir Road, running along Bedok Reservoir Road and ending at the junction of Bedok Reservoir Road, Jalan Eunos and Eunos Link.".

(2) In the principal Order, in the First Schedule, in Part 3, after item 17, insert —

"18. A path (approximately 0.40 kilometre in length) starting at the junction of Bishan Street 13 and Bishan Street 11, running along Bishan Street 11 and ending at the junction of Bishan Street 11 and Braddell Road.".

(3) In the principal Order, in the First Schedule, in Part 6, after item 58, insert —

"59. A path (approximately 0.13 kilometre in length) starting at the junction of North Bridge Road and Coleman Street near Peninsula Plaza, running along Coleman Street and ending at the junction of Coleman Street and Hill Street near Grand Park City Hall.". (4) In the principal Order, in the First Schedule, in Part 13, after item 31, insert —

"32. A path (approximately 0.27 kilometre in length) starting at the junction of Flora Drive and Flora Road, running along Flora Road and ending at the junction of Flora Road and Old Tampines Road.".

(5) In the principal Order, in the First Schedule, in Part 15, after item 8, insert —

- "9. A path (approximately 0.17 kilometre in length) starting at the junction of Commonwealth Avenue and North Buona Vista Link, running along North Buona Vista Link and ending at the junction of North Buona Vista Link and North Buona Vista Drive.
- 10. A path (approximately 0.12 kilometre in length) starting at the junction of Portsdown Road and Biopolis Road, running along Biopolis Road and ending at the junction of Biopolis Road and One-North Link.
- 11. A path (approximately 0.24 kilometre in length) starting at the junction of One-North Link and Biopolis Road, running along Biopolis Road and ending at Biopolis Road near lamp post 14F.
- 12. A path (approximately 0.20 kilometre in length) starting at bus stop number 18149, running along North Buona Vista Road and Portsdown Road and ending at the junction of Portsdown Road and Nepal Park.
- 13. A path (approximately 0.11 kilometre in length) starting at the junction of Nepal Park and Portsdown Road, running along Portsdown Road and ending at the junction of Portsdown Road and One-North Gateway.
- 14. A path (approximately 0.14 kilometre in length) starting at the junction of Fusionopolis Place and Portsdown Road, running along Portsdown Road and ending at the junction of Portsdown Road and North Buona Vista Road.
- 15. A path (approximately 0.28 kilometre in length) starting at the junction of Portsdown Road and North Buona Vista Road, running along North Buona Vista Road and ending at the junction of North Buona Vista Road and Ayer Rajah Avenue.
- 16. A path (approximately 0.12 kilometre in length) starting near One-North MRT station Exit A, running along Ayer Rajah Avenue and ending at the junction of Ayer Rajah Avenue and Fusionopolis Way.
- 17. A path (approximately 0.13 kilometre in length) starting at the junction of Fusionopolis Way and Ayer Rajah Avenue, running along Ayer Rajah Avenue and ending at the junction of Ayer Rajah Avenue and Fusionopolis Walk.

- 18. A path (approximately 0.08 kilometre in length) starting at the junction of Fusionopolis Walk and Ayer Rajah Avenue, running along Ayer Rajah Avenue and ending at the junction of Ayer Rajah Avenue and One-North Crescent.
- 19. A path (approximately 0.24 kilometre in length) starting at the junction of Ayer Rajah Crescent and Ayer Rajah Avenue, running along Ayer Rajah Avenue and ending at the junction of Ayer Rajah Avenue and North Buona Vista Road.
- 20. A path (approximately 0.60 kilometre in length) starting at Ayer Rajah Avenue, running along Ayer Rajah Crescent and ending at Ayer Rajah Crescent near Block 51A.
- 21. A path (approximately 0.29 kilometre in length) starting at the junction of Ayer Rajah Crescent and One-North Avenue, running along One-North Avenue and ending at the junction of One-North Avenue, Ayer Rajah Avenue and One-North Crescent.
- 22. A path (approximately 0.06 kilometre in length) starting at Media Circle near lamp post 8, running along Media Circle and ending at the junction of Media Circle and Portsdown Road.
- 23. A path (approximately 0.15 kilometre in length) starting from the junction of Media Circle and Portsdown Road, running along Portsdown Road and ending at the carpark entrance of Mediapolis@One-North at Stars Avenue.
- 24. A path (approximately 0.15 kilometre in length) starting from the vehicular access to Infinite Studios, running along Media Circle and ending at the junction of Media Circle and One-North Avenue.
- 25. A path (approximately 0.08 kilometre in length) starting at One-North Crescent near lamp post 1F, running along One-North Crescent and ending at the junction of One-North Crescent and Portsdown Road.".

(6) In the principal Order, in the First Schedule, in Part 20, replace item 6 with —

"6. A path (approximately 0.60 kilometre in length) starting at the junction of Tampines Avenue 5 and Tampines Avenue 4, running along Tampines Avenue 4 and ending at the SPC Petrol Station along Tampines Avenue 4.".

(7) In the principal Order, in the First Schedule, in Part 22, after item 58, insert —

"59. A path (approximately 0.79 kilometre in length) starting at the junction of Yishun Avenue 7 and Yishun Avenue 8, running along Yishun

Avenue 8 and ending at the junction of Yishun Avenue 8 and Yishun Avenue 9.".

- (8) In the principal Order, in the First Schedule, in Part 24
  - (a) replace item 5 with
    - "5. A path (approximately 0.45 kilometre in length) starting at the junction of Bukit Panjang Ring Road and Segar Road, running along Bukit Panjang Ring Road and ending at the junction of Bukit Panjang Ring Road, Segar Road and Fajar Road."; and
  - (b) after item 23, insert
    - "24. A path (approximately 0.20 kilometre in length) starting at the junction of Senja Road and Bukit Panjang Ring Road, running along Bukit Panjang Ring Road and ending at the bicycle crossing near West Spring Primary School along Senja Close.
    - 25. A path (approximately 0.15 kilometre in length) starting at the bicycle crossing near Block 550A Senja Close, running along Bukit Panjang Ring Road and ending at the junction of Bukit Panjang Ring Road, Segar Road and Jelapang Road.".

(9) In the principal Order, in the First Schedule, in Part 25, replace items 1 and 2 with —

- "1. A path (approximately 0.20 kilometre in length) starting at Kampong Java Road near lamp post 7, running west and then south-easterly on level ground in between Kampong Java Road and Bukit Timah Road and ending at bus stop number 40039 along Bukit Timah Road.
  - 2. A path (approximately 0.34 kilometre in length) starting at the junction of Malcolm Road and Whitley Road, running along Whitley Road and ending at the junction of Whitley Road and Dunearn Road.".

## **Amendment of Third Schedule**

**3.** In the principal Order, in the Third Schedule, after item 135, insert —

"136. Potong Pasir Avenue 3 Park Connector (approximately 0.45 kilometre in length) starting near the shelter opposite Block 144 Potong Pasir Avenue 3, running along Potong Pasir Avenue 3 and ending at the junction of Potong Pasir Avenue 3 and Potong Pasir Avenue 1.".
