## BANKING ACT (CHAPTER 19)

## BANKING (AMENDMENT NO. 2) REGULATIONS 2019

In exercise of the powers conferred by section 78(1) of the Banking Act, the Monetary Authority of Singapore makes the following Regulations:

## Citation and commencement

**1.** These Regulations are the Banking (Amendment No. 2) Regulations 2019 and come into operation on 28 January 2020.

## Amendment of regulation 20A

- **2.** Regulation 20A of the Banking Regulations (Rg 5) is amended
  - (a) by deleting sub-paragraphs (a) and (b) of paragraph (1) and substituting the following sub-paragraphs:
    - "(a) the business of providing a money-changing service;
    - (b) the business of providing a cross-border money transfer service."; and
  - (b) by deleting paragraph (2) and substituting the following paragraph:
    - "(2) In this regulation, "cross-border money transfer service" and "money-changing service" have the meanings given by section 2(1) of the Payment Services Act 2019 (Act 2 of 2019).".
