Citation and commencement

1. This Order may be cited as the Housing and Development (Precincts for Upgrading Works) (Home Improvement Programme) (No. 12) Order 2014 and shall come into operation on 26 December 2014.

2. The parts of the housing estates of the Board described in the Schedule are hereby declared to be precincts for the purpose of carrying out upgrading works in connection with the Home Improvement Programme.

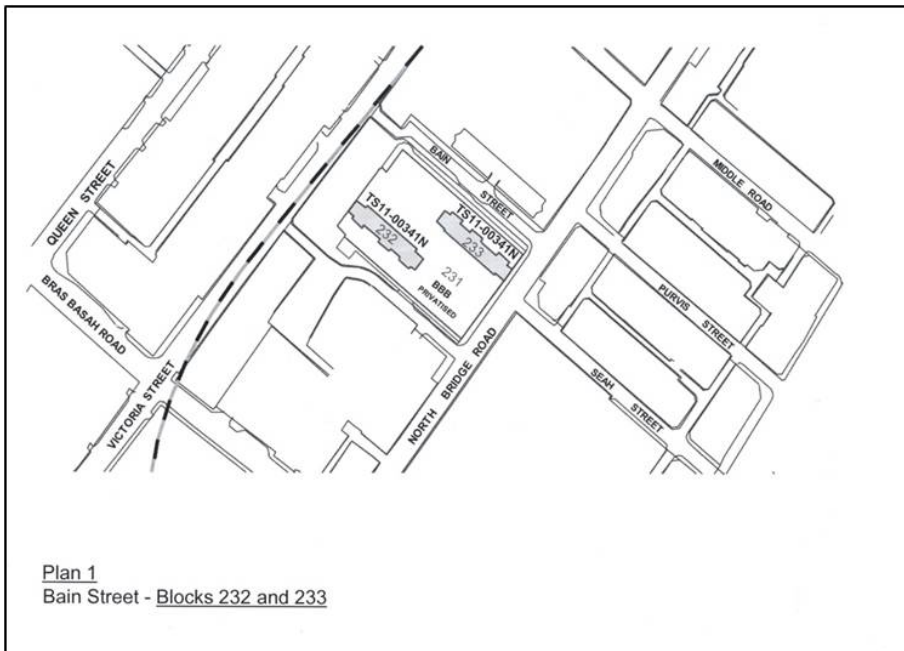

BAIN STREET



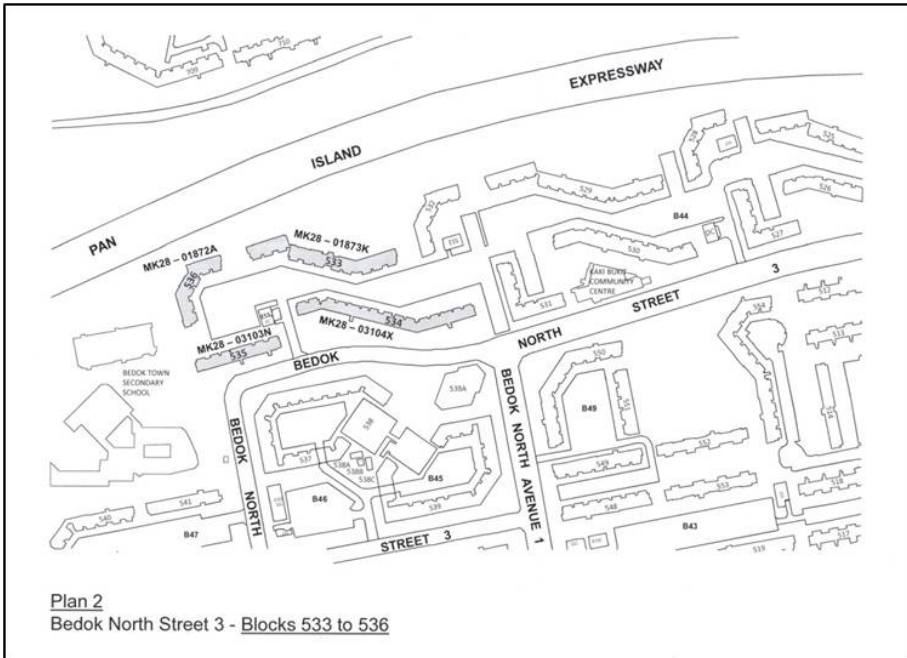

BEDOK NORTH STREET 3

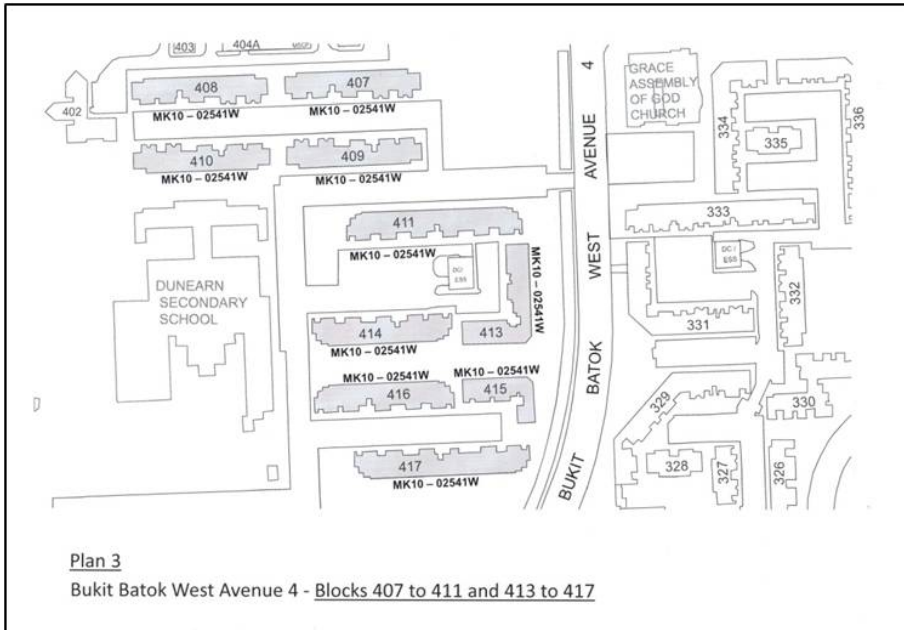

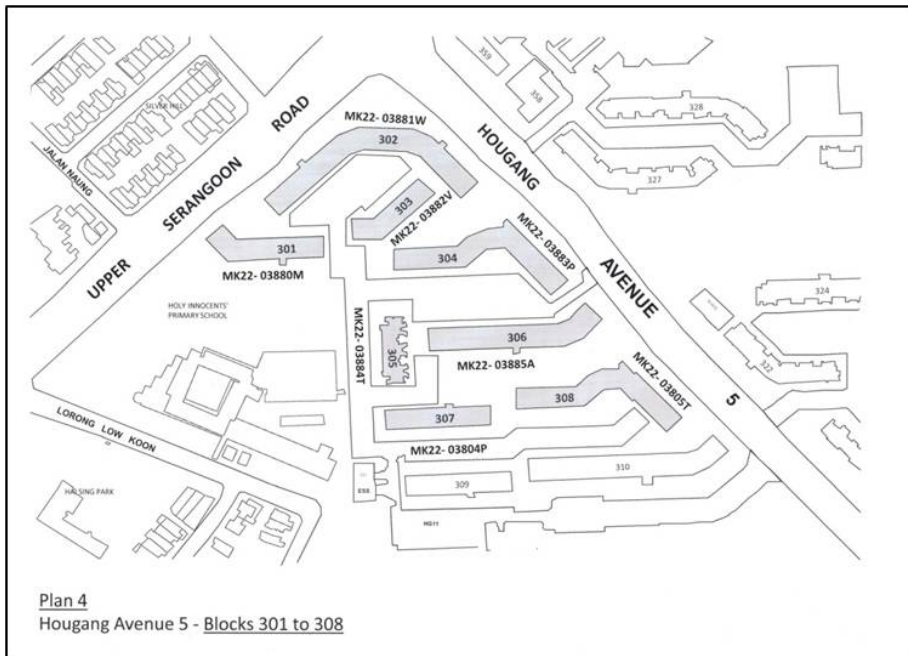
PLAN 3

BUKIT BATOK WEST AVENUE 4



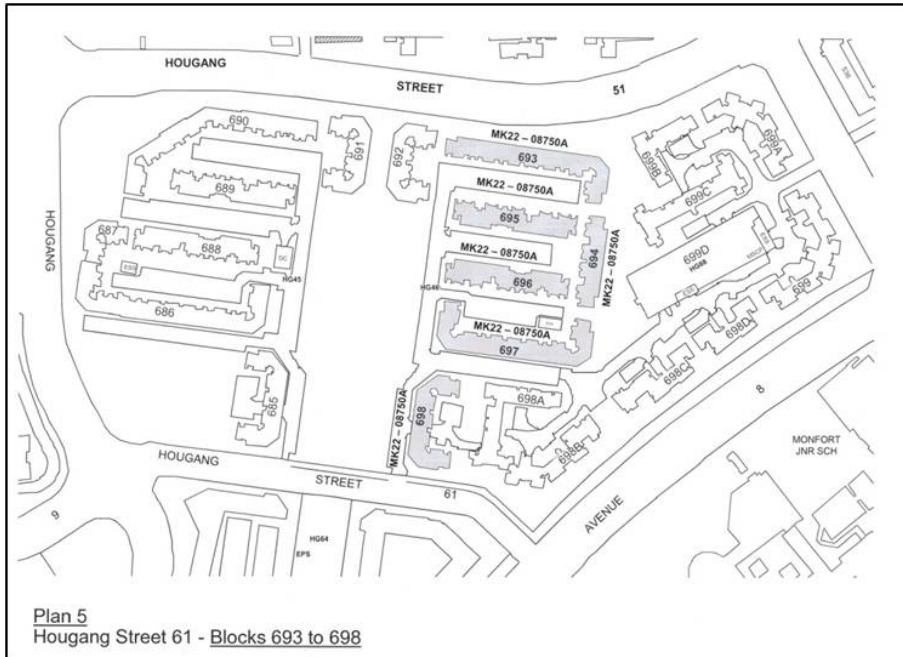

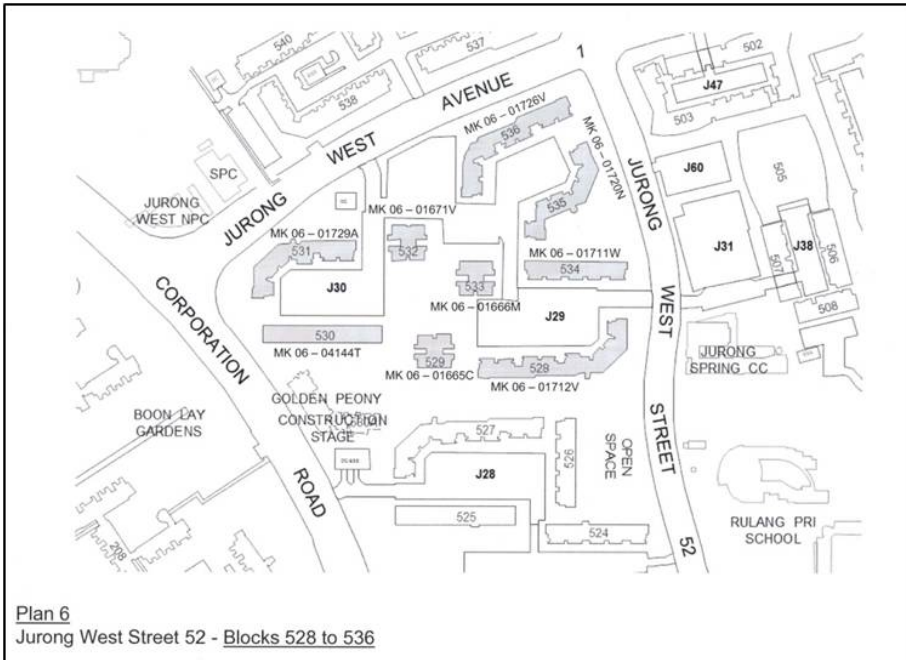

JURONG WEST STREET 52

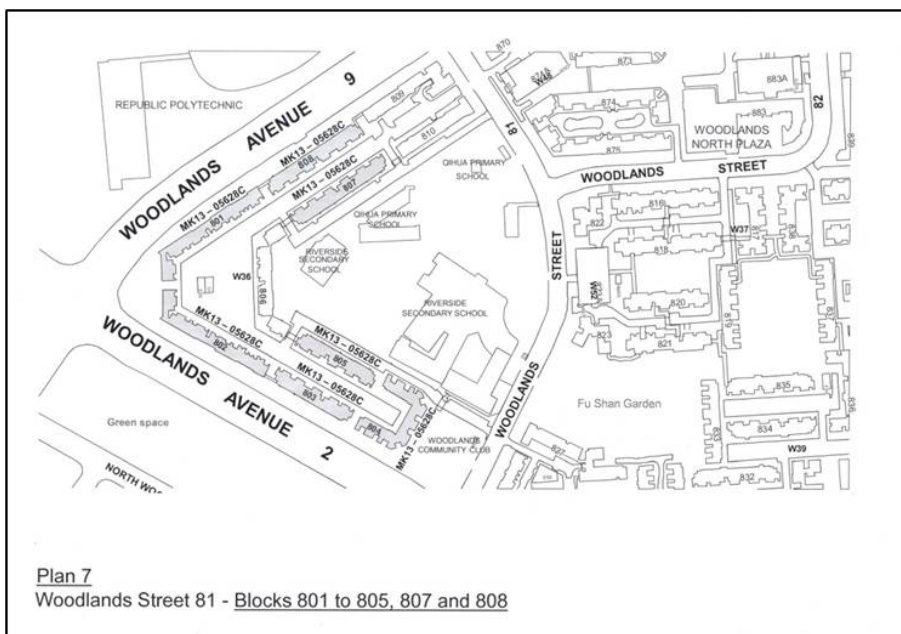
