PRISONS ACT (CHAPTER 247)

PRISONS ACT (AMENDMENT OF FIRST AND SECOND SCHEDULES) ORDER 2019

In exercise of the powers conferred by section 82(1) of the Prisons Act, the Minister for Home Affairs makes the following Order:

Citation and commencement

1. This Order is the Prisons Act (Amendment of First and Second Schedules) Order 2019 and comes into operation on 1 January 2020.

Amendment of First Schedule

the Children and Young Persons (Amendment) Act 2019).".
