REMOTE GAMBLING (HEALTH PROMOTION BOARD — EXEMPTION) (NO. 4) ORDER 2022

ARRANGEMENT OF PARAGRAPHS

In exercise of the powers conferred by section 40 of the Remote Gambling Act 2014, the Minister for Home Affairs makes the following Order:

Citation

1. This Order is the Remote Gambling (Health Promotion Board — Exemption) (No. 4) Order 2022.

Definitions

- 2. In this Order, unless the context otherwise requires
 - "draw" means the draw to be held as part of the promotion at 3 Second Hospital Avenue, Singapore 168937 at 10 a.m. on 11 February 2022;
 - "organiser" means the Health Promotion Board established by section 3 of the Health Promotion Board Act 2001;

"promotion" means the promotion called "National Steps ChallengeTM Season 6 Anytime Fitness Thematic Challenge" that was made available from 6 December 2021 to 2 January 2022 (both dates inclusive) on the Healthy 365 mobile application platform maintained by the organiser;

"public accountant" has the meaning given by section 2(1) of the Accountants Act 2004.

Exemption

- **3.**—(1) The organiser is exempt from sections 11, 13, 15 and 17 of the Act in respect of the promotion and the draw.
- (2) The exemption is subject to compliance by the organiser with the conditions specified in the Schedule.

THE SCHEDULE

Paragraph 3(2)

CONDITIONS

- 1. The organiser must keep a record of the name and email address of every participant of the draw.
- 2. Only persons in the employment of the organiser may conduct the draw.
- 3. The draw must
 - (a) be conducted in public; or
 - (b) if conducted in private by means of a computerised system, be witnessed and audited by a public accountant who is not in the employment of the organiser.
- 4. The organiser must undertake to ensure that every winner is notified by email.
- 5. The organiser must, before the start of the draw, undertake to ensure that an audited statement of accounts and the results of the draw are sent by registered post to the Head, Specialised Crime Policy Branch, Criminal Investigation Department, Singapore Police Force, no later than 12 May 2022.
