ORGANISED CRIME ACT 2015 (AMENDMENT OF SCHEDULE) ORDER 2022

In exercise of the powers conferred by section 80(1) of the Organised Crime Act 2015, the Minister for Home Affairs makes the following Order:

Citation and commencement

1. This Order is the Organised Crime Act 2015 (Amendment of Schedule) Order 2022 and comes into operation on 9 November 2022.

Amendment of Schedule

- (o) renumber item 31 as item 29;
- (p) renumber item 32 as item 30;
- (q) renumber item 33 as item 31;
- (r) renumber item 34 as item 32;
- (s) after item 32 (as renumbered by sub-paragraph (r)), insert —
