# SINGAPORE ACADEMY OF LAW (AMENDMENT NO. 4) RULES 2023

In exercise of the powers conferred by section 27 of the Singapore Academy of Law Act 1988, the Senate of the Singapore Academy of Law makes the following Rules:

#### Citation and commencement

**1.** These Rules are the Singapore Academy of Law (Amendment No. 4) Rules 2023 and come into operation on 1 January 2024.

## Amendment of rule 13

**2.** In the Singapore Academy of Law Rules (R 1) (called in these Rules the principal Rules), in rule 13, replace "\$86.40" with "\$87.20".

#### **Amendment of Third Schedule**

**3.** In the principal Rules, in the Third Schedule, in paragraphs 1 and 2, replace "5.4%" with "5.45%".

## **Amendment of Fourth Schedule**

- 4. In the principal Rules, in the Fourth Schedule
  - (*a*) in Part IV, in the Part heading, after "2023)", insert "AND FOR 2024 (IF PAID BEFORE 1 JANUARY 2024)";
  - (b) in Part IV, after "January 2023)", insert "and for 2024 (if paid before 1 January 2024)";
  - (c) in Part IV, in item 2, replace "rule 3(4A)" with "rule 3(4) or (4A), as the case may be"; and
