ROAD TRAFFIC  
(ELECTRONIC ROAD PRICING SYSTEM)  
(AMENDMENT NO. 3) RULES 2020

In exercise of the powers conferred by section 34D of the Road Traffic Act, the Minister for Transport makes the following Rules:

**Citation and commencement**

1. These Rules are the Road Traffic (Electronic Road Pricing System) (Amendment No. 3) Rules 2020 and come into operation on 12 October 2020.

**Amendment of First Schedule**

2. The First Schedule to the Road Traffic (Electronic Road Pricing System) Rules 2015 (G.N. No. S 226/2015) is amended —

(a) by deleting Division 2 of Part 2 and substituting the following Division:
