### **PUBLIC TRANSPORT COUNCIL ACT 1987**

#### **PUBLIC TRANSPORT COUNCIL (TICKET PAYMENT SERVICE LICENCE) (EXEMPTION) (AMENDMENT) ORDER 2022**

In exercise of the powers conferred by section 70 of the Public Transport Council Act 1987, the Public Transport Council makes the following Order:

#### **Citation and commencement**

1. This Order is the Public Transport Council (Ticket Payment Service Licence) (Exemption) (Amendment) Order 2022 and comes into operation on 16 November 2022.
