HEALTH PRODUCTS ACT (CHAPTER 122D)

HEALTH PRODUCTS (MEDICAL DEVICES) (AMENDMENT) REGULATIONS 2019

In exercise of the powers conferred by section 71 of the Health Products Act, the Health Sciences Authority, with the approval of the Minister for Health, makes the following Regulations:

Citation and commencement

1. These Regulations are the Health Products (Medical Devices) (Amendment) Regulations 2019 and come into operation on 2 April 2019.

Amendment of Fourth Schedule

2. Part 1 of the Fourth Schedule to the Health Products (Medical Devices) Regulations 2010 (G.N. No. S 436/2010) is amended —

 - (k) by deleting “\$75,000” in item 2(e)(ii) and substituting “\$75,200”;
 - (l) by deleting “\$35” in item 3(b) and substituting “\$36”;
 - (m) by deleting “\$60” in item 3(c) and substituting “\$62”;
 - (n) by deleting “\$120” in item 3(d) and substituting “\$124”;
 - (o) by deleting “\$500” in item 4(b) and (c)(i) and substituting in each case “\$515”;
 - (p) by deleting “\$1,700” in item 4(c)(ii) and substituting “\$1,750”;
 - (q) by deleting “\$2,800” in item 4(c)(iii) and substituting “\$2,880”;
 - (r) by deleting “\$1,000” in item 6(a), (b) and (c) and substituting in each case “\$1,030”;
 - (s) by deleting “\$150” in item 7(a), (b) and (c) and substituting in each case “\$155”;
 - (t) by deleting “\$800” in item 8 and substituting “\$820”;
 - (u) by deleting “\$350” in item 9(a) and substituting “\$360”;
 - (v) by deleting “\$150” in item 9(b) and substituting “\$155”;
 - (w) by deleting “\$250” in items 9(c) and 10 and substituting in each case “\$258”; and

(x) by deleting “\$50” in items 11 and 12(a) and (b) and substituting in each case “\$52”.
