In exercise of the powers conferred by section 40 of the Remote Gambling Act 2014, the Minister for Home Affairs makes the following Order:

#### **Citation**

1. This Order is the Remote Gambling (Land Transport Authority of Singapore — Exemption) (No. 2) Order 2021.

#### **Definitions**

2. In this Order, unless the context otherwise requires —

“draw” means the draw to be held as part of the promotion at 1 Hampshire Road, Block 4 Level 2, Singapore 219428 at 9 a.m. on 6 December 2021;

“organiser” means the Land Transport Authority of Singapore established by section 3 of the Land Transport Authority of Singapore Act (Cap. 158A);

“promotion” means the promotion called “Caring Commuter Week 2021 Social Media Quiz Contest” that is to be made

available from 30 November 2021 to 5 December 2021 (both dates inclusive) on the Facebook and Instagram social media platforms maintained by the organiser;

“public accountant” has the meaning given by section 2(1) of the Accountants Act (Cap. 2).

### **Exemption**

3.—(1) The organiser is exempt from sections 11, 13, 15 and 17 of the Act in respect of the promotion and the draw.

(2) The exemption is subject to compliance by the organiser with the conditions specified in the Schedule.

## THE SCHEDULE

Paragraph 3(2)

### CONDITIONS

1. All the following details must be included in publicity material that must be freely accessible to every participant of the draw:
  - (a) the name and address of the organiser;
  - (b) the details of the prizes to be distributed;
  - (c) the manner in which the prizes will be distributed;
  - (d) the time, date and place of the draw;
  - (e) how a person may participate in the draw;
  - (f) the manner in which the draw is to be conducted.
2. The organiser must keep a record of the Facebook or Instagram username of every participant of the draw.
3. Only persons in the employment of the organiser may conduct the draw.
4. The draw must —
  - (a) be conducted in a manner where members of the public or a section of the public may witness the draw; or
  - (b) if conducted in private by means of a computerised system, be witnessed and audited by a public accountant who is not in the employment of the organiser.
5. The organiser must undertake to ensure that every winner is notified by direct message through Facebook or Instagram.

THE SCHEDULE — *continued*

6. The organiser must, before the start of the draw, undertake to ensure that an audited statement of accounts and the results of the draw are sent by registered post to the Head, Specialised Crime Policy Branch, Criminal Investigation Department, Singapore Police Force, no later than 7 March 2022.
