### **CORRUPTION, DRUG TRAFFICKING AND OTHER SERIOUS CRIMES (CONFISCATION OF BENEFITS) ACT 1992 (AMENDMENT OF SECOND SCHEDULE) ORDER 2022**

In exercise of the powers conferred by section 84 of the Corruption, Drug Trafficking and Other Serious Crimes (Confiscation of Benefits) Act 1992, the Minister for Home Affairs makes the following Order:

#### **Citation and commencement**

**1.** This Order is the Corruption, Drug Trafficking and Other Serious Crimes (Confiscation of Benefits) Act 1992 (Amendment of Second Schedule) Order 2022 and comes into operation on 3 December 2022.

#### **Amendment of Second Schedule**

**2.** In the Second Schedule to the Corruption, Drug Trafficking and Other Serious Crimes (Confiscation of Benefits) Act 1992 —

- (f) in Part 5, in item 298, in the first column, after “Section 4”, insert “(as in force before 1 August 2022)”;
- (g) in Part 5, in item 299, in the first column, after “Section 6”, insert “(as in force before 1 August 2022)”;
- (h) in Part 13, in item 397, in the first column, after “Section 8”, insert “(as in force before 1 August 2022)”;
- (i) in Part 13, in item 398, in the first column, after “Section 9”, insert “(as in force before 1 August 2022)”;
- (j) in Part 13, in item 399, in the first column, after “Section 10”, insert “(as in force before 1 August 2022)”;
- (k) in Part 13, in item 400, in the first column, after “Section 11”, insert “(as in force before 1 August 2022)”;
- (l) in Part 13, in item 401, in the first column, after “Section 12”, insert “(as in force before 1 August 2022)”;
- (m) in Part 13, in item 402, in the first column, after “Section 13”, insert “(as in force before 1 August 2022)”;
- (n) after Part 23, insert —
