## EDUCATION SERVICE INCENTIVE PAYMENT ACT 2001

# EDUCATION SERVICE INCENTIVE PAYMENT (CONNECT PLAN) (AMENDMENT NO. 2) REGULATIONS 2023

In exercise of the powers conferred by section 3(1) of the Education Service Incentive Payment Act 2001, the Minister for Education makes the following Regulations:

### Citation and commencement

- 1.—(1) These Regulations are the Education Service Incentive Payment (CONNECT Plan) (Amendment No. 2) Regulations 2023.
- (2) Regulation 2(c) is deemed to have come into operation on 3 October 2022.
- (3) Regulation 2(b), (d) and (f) is deemed to have come into operation on 1 April 2023.
- (4) Regulation 2(a), (g) and (h) is deemed to have come into operation on 27 November 2023.
- (5) Regulation 2(e) is deemed to have come into operation on 1 December 2023.
