# INFRASTRUCTURE PROTECTION (PROTECTED PLACES) (NO. 3) ORDER 2023

#### ARRANGEMENT OF PARAGRAPHS

In exercise of the powers conferred by sections 14(1) and 19(1) of the Infrastructure Protection Act 2017, the Minister for Home Affairs makes the following Order:

## Citation and commencement

**1.** This Order is the Infrastructure Protection (Protected Places) (No. 3) Order 2023 and comes into operation on 24 February 2023.

## Premises declared to be protected place and surrounding area

**2.**—(1) The premises described in the second column of Part 1 of the Schedule are declared to be a protected place for the purposes of the Act, and the person specified in the first column of Part 1 of that Schedule is designated as the authority of the protected place.

(2) The premises described in Part 2 of the Schedule are specified to be the surrounding area of the protected place for the purposes of sections 27 and 28 of the Act.

### Revocation

**3.** Revoke the Protected Places (No. 3) Order 2011 (G.N. No. S 327/2011).




