### **CENTRAL PROVIDENT FUND ACT 1953**

#### **CENTRAL PROVIDENT FUND (PUBLIC SECTOR EMPLOYEES) (AMENDMENT) REGULATIONS 2024**

In exercise of the powers conferred by section 77(1) of the Central Provident Fund Act 1953, the Minister for Manpower, after consulting with the Central Provident Fund Board, makes the following Regulations:

#### **Citation and commencement**

**1.** These Regulations are the Central Provident Fund (Public Sector Employees) (Amendment) Regulations 2024 and come into operation on 1 January 2025.

#### **Amendment of First Schedule**

**2.** In the Central Provident Fund (Public Sector Employees) Regulations 2011 (G.N. No. S 106/2011) (called in these Regulations the principal Regulations), in the First Schedule —

- (a) in paragraphs 1, 2, 3 and 15, replace “1 January 2024” with “1 January 2025”;
- (b) in paragraph 1(i), in column (3), replace “23.25%” with “24.375%”;
- (c) in paragraph 1(i), in column (3), replace “31%” wherever it appears with “32.5%”;
- (d) in paragraph 1(i), in column (4), replace “12%” with “12.75%”;
- (e) in paragraph 1(i), in column (4), replace “16%” wherever it appears with “17%”;
- (f) in paragraph 1(ii), in column (1), replace “16.5%” with “17.625%”;

- (g) in paragraph 1(ii), in column (1), replace “22%” wherever it appears with “23.5%”;
- (h) in paragraph 1(ii), in column (2), replace “7.875%” with “8.625%”;
- (i) in paragraph 1(ii), in column (2), replace “10.5%” wherever it appears with “11.5%”;
- (j) in paragraph 2(i), in column (3), replace “15%” with “15.375%”;
- (k) in paragraph 2(i), in column (3), replace “20%” wherever it appears with “20.5%”;
- (l) in paragraph 2(ii), in column (1), replace “12.375%” with “12.75%”;
- (m) in paragraph 2(ii), in column (1), replace “16.5%” wherever it appears with “17%”;
- (n) in paragraph 3(i), in column (3), replace “20.625%” with “21%”;
- (o) in paragraph 3(i), in column (3), replace “27.5%” wherever it appears with “28%”;
- (p) in paragraph 3(ii), in column (1), replace “14.25%” with “14.625%”; and
- (q) in paragraph 3(ii), in column (1), replace “19%” wherever it appears with “19.5%”.

### **Amendment of Second Schedule**

#### **3. In the principal Regulations, in the Second Schedule —**

- (a) in paragraphs 1, 2, 3 and 15, replace “1 January 2024” with “1 January 2025”;
- (b) in paragraph 1(i), in column (4), replace “15%” wherever it appears with “15.5%”;
- (c) in paragraph 1(i), in columns (4) and (5), replace “0.48” with “0.51”;

- (d) in paragraph 1(i), in column (4), replace “31%” wherever it appears with “32.5%”;
  - (e) in paragraph 1(i), in column (5), replace “16%” wherever it appears with “17%”;
  - (f) in paragraph 1(ii), in column (2), replace “11.5%” wherever it appears with “12%”;
  - (g) in paragraph 1(ii), in columns (2) and (3), replace “0.315” with “0.345”;
  - (h) in paragraph 1(ii), in column (2), replace “22%” wherever it appears with “23.5%”;
  - (i) in paragraph 1(ii), in column (3), replace “10.5%” wherever it appears with “11.5%”;
  - (j) in paragraph 2(i), in column (4), replace “15%” wherever it appears with “15.5%”;
  - (k) in paragraph 2(i), in column (4), replace “20%” wherever it appears with “20.5%”;
  - (l) in paragraph 2(ii), in column (2), replace “11.5%” wherever it appears with “12%”;
  - (m) in paragraph 2(ii), in column (2), replace “16.5%” wherever it appears with “17%”;
  - (n) in paragraph 3(i), in column (4), replace “15%” wherever it appears with “15.5%”;
  - (o) in paragraph 3(i), in column (4), replace “27.5%” wherever it appears with “28%”;
  - (p) in paragraph 3(ii), in column (2), replace “11.5%” wherever it appears with “12%”; and
  - (q) in paragraph 3(ii), in column (2), replace “19%” wherever it appears with “19.5%”.

**Amendment of Third Schedule****4. In the principal Regulations, in the Third Schedule —**

- (a) in paragraphs 1 and 8, replace “1 January 2024” with “1 January 2025”;
- (b) in paragraph 1(i), in column (3), replace “23.25%” wherever it appears with “24.375%”;
- (c) in paragraph 1(i), in column (4), replace “12%” wherever it appears with “12.75%”;
- (d) in paragraph 1(ii), in column (1), replace “16.5%” wherever it appears with “17.625%”; and
- (e) in paragraph 1(ii), in column (2), replace “7.875%” wherever it appears with “8.625%”.
