# Regulation

In exercise of the powers conferred by section 75 of the Adoption of Children Act 2022, the Minister for Social and Family Development makes the following Regulations:

#### Citation and commencement

**1.** These Regulations are the Adoption of Children (Prescribed Offences) Regulations 2024 and come into operation on 15 October 2024.

#### Prescribed offences

2. The offences for the purposes of section 5(1)(d) of the Act are as specified in the Schedule.

#### PRESCRIBED OFFENCES

  - (b) an offence under section 80 of that Act, read with any provision mentioned in paragraph (a).
- 7. Any of the following offences under the Criminal Law (Temporary Provisions) Act 1955:
  - (a) an offence under section 3(1), (2) or (3) of that Act;
  - (b) an offence under section 17(1) of that Act, read with any provision mentioned in paragraph (a);
  - (c) an offence under section 19 of that Act, read with any provision mentioned in paragraph (a) or committed in relation to the offence mentioned in paragraph (b) or (d);

- 14. An offence under section 42(2) of the Mental Capacity Act 2008.

- 16. Any offence under the Misuse of Drugs Act 1973.

  - (b) an offence under Chapter 6, 6B or 16 of that Code;

- 20. An offence under section 3 or 6(1) of the Prevention of Human Trafficking Act 2014.

- 22. Any of the following offences under the Public Order and Safety (Special Powers) Act 2018:
  - (a) an offence under section 39(1), 40(1) or 41(1) or (3) of that Act;
  - (b) an offence under section 45 or 46 of that Act, read with any provision mentioned in paragraph (a).
- 23. An offence under section 14(2) or (3), 15(1), 16(1) or (2), 17, 18 or 23(2) of the Societies Act 1966.
- 24. Any offence under the Terrorism (Suppression of Bombings) Act 2007.
- 25. Any offence under the Terrorism (Suppression of Financing) Act 2002.
- 26. Any offence under the Terrorism (Suppression of Misuse of Radioactive Material) Act 2017.
- 27. An offence under section 9(a) of the Trade Disputes Act 1941.
- 28. An offence under section 14(10) or (12) or 15(8) of the Vulnerable Adults Act 2018.
- 29. An offence under section 60A(6), 60B(9), 60C(9), 61(11), 61A(10) or 62(4) or Part 11 of the Women's Charter 1961.

- 30. An attempt to commit any offence specified in this Schedule.
- 31. The abetment of the commission of any offence specified in this Schedule.
- 32. Being a party to a criminal conspiracy to commit any offence specified in this Schedule.
