ACTIVE MOBILITY ACT 2017 (ACT 3 OF 2017)

ACTIVE MOBILITY (HUMFREE — EXEMPTION) ORDER 2020

ARRANGEMENT OF PARAGRAPHS

Paragraph

In exercise of the powers conferred by section 66 of the Active Mobility Act 2017, the Minister for Transport makes the following Order:

Citation

1. This Order is the Active Mobility (Humfree — Exemption) Order 2020.

Definitions

- 2. In this Order
 - "Humfree" means the company incorporated under the Companies Act (Cap. 50) as Humfree Pte. Ltd. (UEN 201906582K);
 - "specified shared paths" means the shared paths specified in the Schedule;
 - "specified trial" means the trial conducted by Humfree on the specified shared paths during the following trial times daily

between 14 September 2020 and 14 November 2020 (both dates inclusive):

- (a) from 9 a.m. to 5 p.m.;
- (b) from 7.30 p.m. to 10 p.m.;

"trial personal mobility device" means a personal mobility device that —

- (a) has handlebars;
- (b) is propelled by an electric motor attached to the personal mobility device;
- (c) has a maximum speed not exceeding 25 km/h under all circumstances;
- (d) has an unladen weight not exceeding 20 kilograms;
- (e) has a width not exceeding 700 millimetres; and
- (f) is developed by Humfree and used for the purpose of the specified trial;

"unladen weight" and "width" have the meanings given by regulation 4(2) of the Active Mobility Regulations 2018 (G.N. No. S 251/2018).

Exemption for trial personal mobility device riders

- 3. Sections 19(1)(c), 20A and 28B(1) of the Act do not apply to an individual riding a trial personal mobility device (called in this paragraph the rider) on any of the specified shared paths during and in connection with the specified trial, under the following conditions:
 - (a) the rider has attained 16 years of age and is authorised by Humfree to ride the trial personal mobility device;
 - (b) where the rider is not employed by Humfree the rider is supervised by an employee of Humfree who ensures the safe use of the trial personal mobility device;
 - (c) the rider, when riding the trial personal mobility device
 - (i) wears a light-coloured vest bearing the words "Humfree Pte. Ltd."; and

- (ii) gives way to other users of the specified shared path;
- (d) the trial personal mobility device does not carry, at any time, any other person;
- (e) no other trial personal mobility device is ridden on the specified shared path when the rider is riding the trial personal mobility device;
- (f) where the trial personal mobility device is ridden during the time from 7.30 p.m. to 10 p.m., the rider wears or the trial personal mobility device displays
 - (i) a white light that is clearly visible for a reasonable distance from the front of the rider or device, as the case may be; and
 - (ii) a red light that is clearly visible for a reasonable distance from the back of the rider or device, as the case may be;
- (g) there is in force, at any time the trial personal mobility device is used in connection with the specified trial, a policy of insurance in relation to the trial personal mobility device insuring against any liability in respect of the death of or bodily injury sustained by any person (other than the driver), or property damage suffered by any person, caused by or arising out of the use of the trial personal mobility device;
- (h) the risk under the policy of insurance mentioned in sub-paragraph (g) is assumed by an insurer who, at the time of the issuance of the policy, is lawfully carrying on an insurance business in Singapore.

Exemption for Humfree

4. Section 28B(2) of the Act does not apply to Humfree where it causes or permits an individual exempt under paragraph 3 to ride a trial personal mobility device on any of the specified shared paths.

Paragraph 2

SPECIFIED SHARED PATHS

PART 1

ANG MO KIO AND HOUGANG

- 1. Path (approximately 0.47 kilometre in length) starting at Ang Mo Kio Avenue 8, running along Ang Mo Kio Avenue 3 and ending at Ang Mo Kio Avenue 6.
- 2. Path (approximately 0.13 kilometre in length) starting at Ang Mo Kio Avenue 6, running along Ang Mo Kio Avenue 3 and ending at Ang Mo Kio Street 22.
- 3. Path (approximately 0.34 kilometre in length) starting at Ang Mo Kio Street 22, running along Ang Mo Kio Avenue 3 and ending at Ang Mo Kio Street 23.
- 4. Path (approximately 0.74 kilometre in length) starting at Ang Mo Kio Street 23, running along Ang Mo Kio Avenue 3 and ending at Ang Mo Kio Avenue 1.
- 5. Path (approximately 0.13 kilometre in length) starting at Ang Mo Kio Avenue 3, running along Ang Mo Kio Avenue 1 and ending at Ang Mo Kio Street 22.
- 6. Path (approximately 0.71 kilometre in length) starting at Ang Mo Kio Street 22, running along Ang Mo Kio Avenue 1 and ending at Ang Mo Kio Avenue 6.
- 7. Path (approximately 0.65 kilometre in length) starting at Ang Mo Kio Avenue 6, running along Ang Mo Kio Avenue 1 and ending at Ang Mo Kio Street 32.
- 8. Path (approximately 0.47 kilometre in length) starting at Ang Mo Kio Street 32, running along Ang Mo Kio Avenue 1 and ending at Ang Mo Kio Avenue 8.
- 9. Path (approximately 0.34 kilometre in length) starting at Hougang Avenue 8, running along Hougang Avenue 6 and ending at Buangkok Drive (excluding the path behind bus stop number 64579 near Block 544).
- 10. Ang Mo Kio Avenue 8 Park Connector (approximately 1.10 kilometres in length) starting at the junction of Ang Mo Kio Avenue 3 and Avenue 8, running along Ang Mo Kio Avenue 8 and ending at Bishan-Ang Mo Kio Park.

THE SCHEDULE — continued

- 11. Ang Mo Kio Park Avenue 5 Park Connector (approximately 4.00 kilometres in length) starting at the junction of Ang Mo Kio Avenue 5 and Avenue 6, running along Ang Mo Kio Avenue 5 and ending at Yio Chu Kang Road.
- 12. Ang Mo Kio Park Connector (approximately 1.10 kilometres in length) starting at Bishan-Ang Mo Kio Park, running along Ang Mo Kio Avenue 6 and ending at Ang Mo Kio Town Garden West Park.
- 13. Buangkok Park Connector (approximately 1.50 kilometres in length) starting at the junction of Yio Chu Kang Road and Buangkok Green, running along Buangkok Green and ending at Sengkang East Road.
- 14. Park Connector in Bishan-Ang Mo Kio Park (approximately 3.50 kilometres in length) starting from Bishan Road, along Ang Mo Kio Avenue 1 and ending at Upper Thomson Road.
- 15. The part of the Serangoon Park Connector (approximately 1.77 kilometres in length) starting from Upper Serangoon Road, along Buangkok Drive and ending at Buangkok Green.

PART 2

PUNGGOL

- 1. Path (approximately 0.27 kilometre in length) starting at Punggol Central, running along Punggol East and ending near lamp post 55.
- 2. Path (approximately 0.48 kilometre in length) starting at Edgedale Plains, running along Punggol Central and ending at Punggol East (excluding the path from behind bus stop number 65261 near Block 649 until lamp post 14).
- 3. Path (approximately 0.26 kilometre in length) starting near Oasis LRT station, running along Punggol Drive and ending at Edgefield Plains.
- 4. Path (approximately 0.32 kilometre in length) starting at Punggol Central, running along Edgedale Plains and ending at Punggol Drive.
- 5. Path (approximately 0.50 kilometre in length) starting at Edgefield Plains, running along Punggol Central and ending at Edgedale Plains (excluding the path behind bus stop number 65271 near Block 622A).
- 6. Path (approximately 0.35 kilometre in length) starting at Punggol Road, running along Punggol Central and ending at bus stop number 65281 (excluding the path behind bus stop number 65281 near Block 601B).
- 7. Path (approximately 0.33 kilometre in length) starting at Punggol Drive, running along Punggol Road and ending at Punggol Central.

THE SCHEDULE — continued

- 8. Path (approximately 0.28 kilometre in length) starting at Punggol Place, running along Punggol Central and ending at Punggol Road (excluding the path behind bus stop number 65221 near Block 303D).
- 9. Path (approximately 0.35 kilometre in length) starting at Punggol Walk, running along Punggol Central and ending at Punggol Place (excluding the path near Punggol MRT station).
- 10. Path (approximately 0.32 kilometre in length) starting at Punggol Way, running along Punggol Central and ending at Punggol Walk.
- 11. Path (approximately 0.48 kilometre in length) starting at Sumang Link, running along Punggol Way and ending at Punggol Central (excluding the path near Sumang LRT station between lamp post 52 to lamp post 56 and the path on the vehicular bridge).
- 12. Path (approximately 0.33 kilometre in length) starting at Punggol Central, running along Punggol Way and ending at Punggol Field (excluding the path behind bus stop number 65141 near Block 267A).
- 13. Path (approximately 0.28 kilometre in length) starting at Punggol Way, running along Punggol Field and ending at Punggol Walk (excluding the path behind bus stop number 65339 near Block 268C).
- 14. Path (approximately 0.28 kilometre in length) starting at Punggol Walk, running along Punggol Field and ending at Punggol Place (excluding the path behind bus stop number 65349 near Block 272C).
- 15. Path (approximately 0.34 kilometre in length) starting at Punggol Place, running along Punggol Field and ending at Punggol Road (excluding the path behind bus stop number 65201 near Block 289B).
- 16. Path (approximately 0.27 kilometre in length) starting at Punggol Road, running along Punggol Field and ending at Edgefield Plains (excluding the path behind bus stop number 65151 near Block 196A).
- 17. Path (approximately 0.31 kilometre in length) starting at Punggol Central, running along Punggol Road and ending at Punggol Field (excluding the path behind bus stop number 65089 near Block 199C and the path behind the overhead pedestrian bridge).
- 18. Path (approximately 0.51 kilometre in length) starting at Edgefield Plains, running along Punggol Field and ending at Edgedale Plains.
- 19. Path (approximately 0.35 kilometre in length) starting at Punggol Field, running along Edgedale Plains and ending at Punggol Central.
- 20. Path (approximately 0.49 kilometre in length) starting at Edgedale Plains, running along Punggol Field and ending at Punggol East (excluding the path

- behind bus stop number 65171 near Block 171A and the path near Coral Edge LRT station between lamp post 23 and lamp post 19).
- 21. Path (approximately 0.38 kilometre in length) starting at Punggol Field, running along Punggol East and ending at Punggol Central (excluding the path behind bus stop number 65231 near Block 166A).
- 22. Park Connector in Punggol Park (approximately 1.20 kilometres in length) starting at Hougang Avenue 10 and ending near Sungei Pinang.
- 23. Park Connector in Punggol Waterway (approximately 8.00 kilometres in length) flanking both banks.
- 24. Punggol Promenade (approximately 5.00 kilometres in length) starting from Punggol Point (Old Punggol Road), running along Sungei Serangoon and ending near Tebing Lane.
