In exercise of the powers conferred by section 66 of the Active Mobility Act 2017, the Minister for Transport makes the following Order:

**Citation**

1. This Order is the Active Mobility (CWA Giving Week — Exemption) Order 2019.

**Definitions**

2. In this Order —

“CWA Giving Week” means the event known as Cycling Without Age Singapore Giving Week conducted on the footpaths and shared paths specified in the Schedule from 9.30 a.m. to 1.30 p.m. and from 2.30 p.m. to 5 p.m. on 6 December 2019;

“organiser” means the company incorporated under the Companies Act (Cap. 50) as Cycling Without Age Singapore Ltd. (UEN 201714757N);

“specified e-trishaw” means a three-wheeled pedal cycle that —

- (a) is constructed or adapted for the carriage of passengers;
- (b) is equipped with an electric motor;
- (c) may be propelled by human power or by the electric motor with which it is equipped, or by both; and
- (d) is used by the organiser for the purpose of CWA Giving Week.

### **Exemption for driver of specified e-trishaw**

3. Sections 16(1)(b) and 17(1) of the Act do not apply to an individual who drives a specified e-trishaw on any footpath or shared path specified in the Schedule under the following conditions:

- (a) the individual has completed a training course conducted by the organiser on how to drive an e-trishaw and is authorised by the organiser to drive the specified e-trishaw;
- (b) the specified e-trishaw is driven only during and in connection with CWA Giving Week;
- (c) the specified e-trishaw is only used to carry, for their leisure, passengers who are elderly, unable to walk or have difficulty in walking;
- (d) the specified e-trishaw is not used to carry passengers for hire or reward;
- (e) the individual who drives the specified e-trishaw must —
  - (i) not drive at a speed exceeding 10 km/h;
  - (ii) give way to other users of the footpath or shared path;
  - (iii) not carry, at any time, more than 2 passengers;
  - (iv) drive with all passengers on the specified e-trishaw safely secured; and

- (v) maintain a distance of at least 100 metres from any other specified e-trishaw on the footpath or shared path;
  - (f) no more than 4 other specified e-trishaws are used at any time on all of the footpaths and shared paths specified in the Schedule;
  - (g) the specified e-trishaw is accompanied by a safety marshal who ensures the safe use of the specified e-trishaw;
  - (h) there is in force, at any time the specified e-trishaw is used in connection with CWA Giving Week, a policy of insurance in relation to the specified e-trishaw insuring against any liability in respect of the death of or bodily injury sustained by any person (other than the driver or any passenger of the specified e-trishaw), or property damage suffered by that person, caused by or arising out of the use of the specified e-trishaw.

### SPECIFIED FOOTPATHS AND SHARED PATHS

#### PART 1

#### SPECIFIED FOOTPATHS

1. A footpath (approximately 0.08 kilometre in length) starting at Block 861 Woodlands Street 83 near lamp post 33, running along Woodlands Avenue 7 and ending at the intersection of Woodlands Avenue 7 and Woodlands Avenue 4 near lamp post 62-62A.
2. A footpath in Woodlands Waterfront Park Garden (approximately 0.11 kilometre in length) starting at the entrance of Woodlands Waterfront Park Garden near Admiralty Road West and ending at the entrance of the jetty in Woodlands Waterfront Park Garden.
3. A footpath (approximately 0.38 kilometre in length) starting from the south end of the footbridge across Sungei Cine near Admiralty Road, running within Admiralty Park and ending at the west end of the footbridge across Sungei Cine near Riverside Road.

THE SCHEDULE — *continued*

4. A footpath (approximately 0.39 kilometre in length) starting from the north end of the footbridge across Sungei Cine near Admiralty Road, running within Admiralty Park and ending at the north end of the gravel path within Admiralty Park.
5. A footpath (approximately 0.25 kilometre in length) starting from the south end of the gravel path within Admiralty Park, running within Admiralty Park and ending at the east end of the footbridge across Sungei Cine near Riverside Road.
6. A footpath (approximately 0.39 kilometre in length) starting from the west end of the footbridge across Sungei Cine near Riverside Road, running within Admiralty Park and ending at the east bank of the footbridge across Sungei Cine near 31 Riverside Road.
7. A footpath (approximately 0.37 kilometre in length) starting from the east end of the footbridge across Sungei Cine near Riverside Road, running within Admiralty Park and ending near the amphitheatre within Admiralty Park.
8. A footpath (approximately 0.47 kilometre in length) starting near the amphitheatre within Admiralty Park, running within Admiralty Park and ending at Woodlands (Avenue 2) Park Connector at the intersection of Woodlands Avenue 5 and Woodlands Avenue 2 near lamp post 2-2A.

## PART 2

## SPECIFIED SHARED PATHS

1. The Admiralty West Park Connector (approximately 2.90 kilometres in length) starting at Woodlands Avenue 7, running along Woodlands Avenue 4 and Admiralty Road West and ending at Woodlands Waterfront Park.
2. The part of the Park Connector in Woodlands Waterfront Park Garden (approximately 1.00 kilometre in length) starting from the entrance of Woodlands Waterfront Park Garden near Admiralty Road West and ending at the entrance of the jetty in Woodlands Waterfront Park Garden.
3. The part of Woodlands (Avenue 2) Park Connector (approximately 0.54 kilometre in length) starting at the intersection of Woodlands Avenue 5 and Woodlands Avenue 2 near lamp post 2-2/A, running along Woodlands Avenue 2 and ending before the intersection of Woodlands Avenue 7 and Woodlands Avenue 2 near lamp post 1/1-1/1A.

THE SCHEDULE — *continued*

4. The part of Woodlands (Avenue 7) Park Connector (approximately 0.72 kilometre in length) starting from the intersection of Woodlands Avenue 2 and Woodlands Avenue 7 near lamp post 30-30/A, running along Woodlands Avenue 7 and ending at the intersection of Woodlands Avenue 4 and Woodlands Avenue 7 near lamp post 38.
