## CASINO CONTROL (COMPOSITION OF OFFENCES) REGULATIONS 2010

#### ARRANGEMENT OF REGULATIONS

#### Regulation

- 1. Citation and commencement
- 2. Compoundable offences

In exercise of the powers conferred by section 196(3) of the Casino Control Act, the Casino Regulatory Authority of Singapore, with the approval of the Minister for Home Affairs, hereby makes the following Regulations:

#### Citation and commencement

1. These Regulations may be cited as the Casino Control (Composition of Offences) Regulations 2010 and shall come into operation on 12th February 2010.

### Compoundable offences

- **2.** The following offences may be compounded by the Authority in accordance with section 196 of the Act:
  - (a) any offence (other than a continuing offence) under section 16(3), 62(2), 80(4), 83(3), 95(2), 116(6), (7), (8) and (9), 125(2), 127(3)(b), 132(2), 134(3)(b), 135(2), 136, 170A(4), 170D or 175A of the Act;
