COMMON GAMING HOUSES ACT (CHAPTER 49)

COMMON GAMING HOUSES (EXEMPTION) (NO. 13) NOTIFICATION 2015

ARRANGEMENT OF PARAGRAPHS

Paragraph

- 2. Exemption The Schedule

In exercise of the powers conferred by section 24 of the Common Gaming Houses Act, the Minister for Home Affairs hereby makes the following Notification:

Citation

1. This Notification may be cited as the Common Gaming Houses (Exemption) (No. 13) Notification 2015.

Exemption

- **2.**—(1) The Minister hereby exempts Marina Bay Sands Pte. Ltd. from the provisions of the Act in respect of
 - (a) the "Lucky Fortune Spin" promotion (called the first promotion) to be held from 6 March 2015 to 19 April 2015 (both dates inclusive);
 - (b) the lottery called the "Lucky Fortune Spin Kiosk Game" to be held as part of the first promotion where
 - (i) tickets are issued at all Sands Rewards Club kiosks within the premises of the casino of the Marina Bay Sands from 8.21 p.m. each day between 8 March 2015

- and 15 April 2015 (both dates inclusive) to before 8.20 p.m. the following day; and
- (ii) draws are conducted daily at the Main Casino Floor (Level B2M) at Marina Bay Sands at 8.30 p.m. from 9 March 2015 to 16 April 2015 (both dates inclusive);
- (c) the "Lucky Fortune Spin Finale Draw" promotion (called the second promotion) to be held from 17 April 2015 to 19 April 2015 (both dates inclusive); and
- (d) the lottery called the "Lucky Fortune Spin Finale Draw" to be held as part of the second promotion at the Main Casino Floor (Level B2M) at Marina Bay Sands where draws are conducted as follows:
 - (i) 5 sessions hourly from 8 p.m. to 12 midnight on 17 April 2015 and 18 April 2015, respectively;
 - (ii) 5 sessions hourly from 6 p.m. to 10 p.m. on 19 April 2015.
- (2) The exemption is subject to compliance by Marina Bay Sands Pte. Ltd. with the conditions specified in the Schedule.

THE SCHEDULE

Paragraph 2

CONDITIONS

- The methodology of the promotions, the details of the prizes to be distributed, their manner of distribution and, if the winners are determined solely or partly by a lottery, the time, date and place of the lotteries, must be disclosed in printed publicity material, copies of which must be freely available to all participants.
- 2. Every lottery must be conducted by persons in the employment of Marina Bay Sands Pte. Ltd. only.
- 3. Every lottery must
 - (a) be conducted in public; or
 - (b) if conducted in private by means of a computerised system, be witnessed and audited by a public accountant who is not in the employment of Marina Bay Sands Pte. Ltd.

THE SCHEDULE — continued

- 4. Every lottery must not involve the use of any game, method, device, scheme or competition declared by the Minister in a notification under section 2(3) of the Act.
- 5. Every lottery must not involve the use of any instrument or appliance for gaming declared by the Minister in a notification under section 2(4) of the Act.
- 6. The results of every draw must be announced via the audio-visual system at the draw area, in addition to being displayed on the plasma television sets of the casino at Marina Bay Sands, after each draw is completed.
- 7. Marina Bay Sands Pte. Ltd. must, before the start of any of the lotteries, undertake to ensure that an audited statement of accounts and the results of the lotteries are sent by registered post to the Head, Specialised Crime Policy Branch, Criminal Investigation Department, no later than 20 July 2015.
