#### COMMON GAMING HOUSES (EXEMPTION) (NO. 4) NOTIFICATION 2013

##### ARRANGEMENT OF PARAGRAPHS

In exercise of the powers conferred by section 24 of the Common Gaming Houses Act, the Minister for Home Affairs hereby makes the following Notification:

#### **Citation**

1. This Notification may be cited as the Common Gaming Houses (Exemption) (No. 4) Notification 2013.

#### **Exemption**

2.—(1) The Minister hereby exempts Marina Bay Sands Pte. Ltd. from the provisions of the Act in respect of —

- (a) the “Instant Win To Spin” kiosk games to be held daily from 4 p.m. to 9 p.m.; and
- (b) the “Cash Wonders” draws to be held daily at 6 p.m., 8 p.m. and 10 p.m., respectively,

as part of the “Wonders of Marina Bay Sands Finale” promotion to be held within the integrated resort of Marina Bay Sands during the following periods:

- 
- 
- (i) from 1st March 2013 to 3rd March 2013 (both dates inclusive);
  - (ii) from 31st May 2013 to 2nd June 2013 (both dates inclusive);
  - (iii) from 6th September 2013 to 8th September 2013 (both dates inclusive);
  - (iv) from 6th December 2013 to 9th December 2013 (both dates inclusive);
  - (v) from 7th March 2014 to 9th March 2014 (both dates inclusive);
  - (vi) from 6th June 2014 to 8th June 2014 (both dates inclusive);
  - (vii) from 5th September 2014 to 7th September 2014 (both dates inclusive); and
  - (viii) from 5th December 2014 to 7th December 2014 (both dates inclusive).
- (2) The exemption is subject to compliance by Marina Bay Sands Pte. Ltd. with the conditions specified in the Schedule.

## THE SCHEDULE

Paragraph 2

### CONDITIONS

1. The methodology of the promotion, the details of the prizes to be distributed, their manner of distribution and, if the winners are determined solely or partly by a lottery or draw, the time, date and place of every lottery and draw, shall be disclosed in printed publicity material, copies of which shall be freely available to all participants.
2. Every lottery and draw shall be conducted by persons in the employment of Marina Bay Sands Pte. Ltd. only.
3. Every lottery and draw shall be conducted in public.
4. Every lottery and draw by means of a computerised system which is not conducted in public shall be witnessed and audited by a public accountant who is not in the employment of Marina Bay Sands Pte. Ltd.
5. Every lottery and draw shall not involve the use of any game, method, device, scheme or competition declared by the Minister in a notification under section 2(3) of the Act.

THE SCHEDULE — *continued*

6. Every lottery and draw shall not involve the use of any instrument or appliance for gaming declared by the Minister in a notification under section 2(4) of the Act.
7. Marina Bay Sands Pte. Ltd. shall, before the start of any of the lotteries or draws, undertake to ensure that —
  - (a) the results of the lotteries and draws are to be announced via the AV system at the draw area, in addition to being displayed on the plasma television sets at the same area, after each lottery or draw is completed; and
  - (b) an audited statement of accounts shall, together with the results of the lotteries and draws, be sent by registered post to the Head, Specialised Crime Policy Branch, Criminal Investigation Department, no later than 8th March 2015.
