COMMON GAMING HOUSES ACT (CHAPTER 49)

COMMON GAMING HOUSES (EXEMPTION) (NO. 19) NOTIFICATION 2016

ARRANGEMENT OF PARAGRAPHS

Paragraph

- 2. Exemption The Schedule

In exercise of the powers conferred by section 24 of the Common Gaming Houses Act, the Minister for Home Affairs makes the following Notification:

Citation

1. This Notification is the Common Gaming Houses (Exemption) (No. 19) Notification 2016.

Exemption

2.—(1) The Minister exempts Hard Rock Cafe Pte Ltd (called in this Notification the organiser) from the provisions of the Act in respect of —

- (*a*) the "Auction of Cadillac" event to be held from 31 March 2016 to 12 May 2016 (both dates inclusive); and
- (*b*) the draw to be held at Hard Rock Cafe Singapore at 6 p.m. on 12 May 2016.

(2) The exemption is subject to compliance by the organiser with the conditions specified in the Schedule.

THE SCHEDULE

Paragraph 2(2)

CONDITIONS

- 1. The price of the draw ticket, the name and address of the organiser, and the details of the prizes must be clearly stated on the ticket.
- 2. Each draw ticket must only be issued by way of sale and upon receipt of its price in full.
- 3. The name, identity card number (if available), contact number and email address (if available) of the purchaser of each draw ticket must be recorded on the counterfoil of that ticket.
- 4. The draw must be conducted
 - (a) by the organiser and its officers only; and
 - (b) in public.
- 5. The draw must not involve the use of any game, method, device, scheme or competition declared by the Minister under section 2(3) of the Act
 - (a) to be a lottery for the purposes of the Act; or
 - (b) to be a game of chance, or a mixed game of skill and chance, for the purposes of the Act.
- 6. The draw must not involve the use of any article declared by the Minister under section 2(4) of the Act to be an instrument or appliance for gaming.
- 7. The results of the draw must be published in one major newspaper in Singapore on 13 May 2016.
- 8. The organiser must, before the start of the draw, undertake to ensure that an audited statement of accounts and the results of the draw are sent by registered post to the Head, Specialised Crime Policy Branch, Criminal Investigation Department, no later than 13 August 2016.
