COMMON GAMING HOUSES ACT (CHAPTER 49)

COMMON GAMING HOUSES (EXEMPTION) (NO. 20) NOTIFICATION 2015

ARRANGEMENT OF PARAGRAPHS

In exercise of the powers conferred by section 24 of the Common Gaming Houses Act, the Minister for Home Affairs makes the following Notification:

Citation

1. This Notification may be cited as the Common Gaming Houses (Exemption) (No. 20) Notification 2015.

Exemption

2.—(1) The Minister exempts Marina Bay Sands Pte. Ltd. from the provisions of the Act in respect of —

- (a) the “Super Lucky Slot Seat” promotion to be held from 17 April 2015 to 27 May 2015 (both dates inclusive); and
- (b) the draws to be held —
 - (i) at the Main Casino Floor (Level B2M) at Marina Bay Sands as part of that promotion; and

(ii) in 7 sessions (10 minutes interval) from 8 p.m. to 9 p.m. on 6 May 2015, 13 May 2015, 20 May 2015 and 27 May 2015, respectively.

(2) The exemption is subject to compliance by Marina Bay Sands Pte. Ltd. with the conditions specified in the Schedule.

THE SCHEDULE

Paragraph 2

CONDITIONS

1. The methodology of the promotion, the details of the prizes to be distributed, their manner of distribution and, if the winners are determined solely or partly by a draw, the time, date and place of the draw must be disclosed in printed publicity material, copies of which must be freely available to all participants.
2. Every draw may only be conducted by persons in the employment of Marina Bay Sands Pte. Ltd.
3. Every draw must —
 - (a) be conducted in public; or
 - (b) if conducted in private by means of a computerised system, be witnessed and audited by a public accountant who is not in the employment of Marina Bay Sands Pte. Ltd.
4. Every draw must not involve the use of any game, method, device, scheme or competition declared by the Minister in a notification under section 2(3) of the Act.
5. Every draw must not involve the use of any instrument or appliance for gaming declared by the Minister in a notification under section 2(4) of the Act.
6. Marina Bay Sands Pte. Ltd. must, before the start of the draws, undertake to ensure that an audited statement of accounts and the results of the draws are sent by registered post to the Head, Specialised Crime Policy Branch, Criminal Investigation Department, no later than 28 August 2015.
