COMMON GAMING HOUSES ACT (CHAPTER 49)

COMMON GAMING HOUSES (EXEMPTION) (NO. 18) NOTIFICATION 2013

ARRANGEMENT OF PARAGRAPHS

In exercise of the powers conferred by section 24 of the Common Gaming Houses Act, the Minister for Home Affairs hereby makes the following Notification:

Citation

1. This Notification may be cited as the Common Gaming Houses (Exemption) (No. 18) Notification 2013.

Exemption

- 2.—(1) The Minister hereby exempts the Singapore Turf Club from the provisions of the Act in respect of the "Snap and Win Photography Contest" promotion to be held from 26th April 2013 to 27th May 2013 (both dates inclusive) and the weekly draws to be held at 5 p.m. on 6th May 2013, 13th May 2013, 20th May 2013 and 27th May 2013, respectively, at the Administration Building of the Singapore Racecourse.
- (2) The exemption is subject to compliance by the Singapore Turf Club with the conditions specified in the Schedule.

THE SCHEDULE

Paragraph 2

CONDITIONS

- 1. The methodology of the promotion, the details of the prizes to be distributed, their manner of distribution and, if the winners are determined solely or partly by a draw, the time, date and place of the draw, shall be disclosed in printed publicity material, copies of which shall be freely available to all participants.
- 2. Every draw shall be conducted by the Singapore Turf Club and its officers only.
- 3. Every draw by means of a computerised system which is not conducted in public shall be witnessed and audited by a public accountant who is not an employee of the Singapore Turf Club.
- 4. Every draw shall not involve the use of any game, method, device, scheme or competition declared by the Minister in a notification under section 2(3) of the Act.
- 5. Every draw shall not involve the use of any instrument or appliance for gaming declared by the Minister in a notification under section 2(4) of the Act.
- 6. The Singapore Turf Club shall undertake to ensure that
 - (a) all winners shall be notified in writing by electronic mail or other means; and
 - (b) an audited statement of accounts shall, together with the results of the draws, be sent by registered post to the Head, Specialised Crime Policy Branch, Criminal Investigation Department, no later than 28th August 2013.
