COMMON GAMING HOUSES (EXEMPTION) (NO. 23) NOTIFICATION 2013

ARRANGEMENT OF PARAGRAPHS

In exercise of the powers conferred by section 24 of the Common Gaming Houses Act, the Minister for Home Affairs hereby makes the following Notification:

Citation

1. This Notification may be cited as the Common Gaming Houses (Exemption) (No. 23) Notification 2013.

Exemption

- 2.—(1) The Minister hereby exempts Resorts World at Sentosa Pte. Ltd. from the provisions of the Act in respect of the "Seat of the Hour 2013" promotion to be held from 11th May 2013 to 30th June 2013 (both dates inclusive) (referred to in this Notification as the "relevant period") and the draws to be held between 12 noon and 9.30 p.m., daily, during the relevant period, at the Mass Gaming Area and Maxims within the premises of the casino of Resorts World at Sentosa.
- (2) The exemption is subject to compliance by Resorts World at Sentosa Pte. Ltd. with the conditions specified in the Schedule.

THE SCHEDULE

Paragraph 2

CONDITIONS

- 1. The methodology of the promotion, the details of the prizes to be distributed, their manner of distribution and, if the winners are determined solely or partly by a draw, the time, date and place of the draw, shall be disclosed in printed publicity material, copies of which shall be freely available to all participants.
- 2. Every draw shall be conducted by persons in the employment of Resorts World at Sentosa Pte. Ltd. only.
- 3. Every draw shall be conducted in public.
- 4. Any draw by means of a computerised system which is not conducted in public shall be witnessed and audited by a public accountant who is not in the employment of Resorts World at Sentosa Pte. Ltd.
- 5. Every draw shall not involve the use of any game, method, device, scheme or competition declared by the Minister in a notification under section 2(3) of the Act.
- 6. Every draw shall not involve the use of any instrument or appliance for gaming declared by the Minister in a notification under section 2(4) of the Act.
- 7. Resorts World at Sentosa Pte. Ltd. shall, before the start of any of the draws, undertake to ensure that
 - (a) the results of the draws will be announced via the Public Address system of the casino; and
 - (b) an audited statement of accounts shall, together with the results of the draws, be sent by registered post to the Head, Specialised Crime Policy Branch, Criminal Investigation Department, no later than 1st October 2013.
