COMMON GAMING HOUSES (EXEMPTION) (NO. 29) NOTIFICATION 2012

ARRANGEMENT OF PARAGRAPHS

In exercise of the powers conferred by section 24 of the Common Gaming Houses Act, the Minister for Home Affairs hereby makes the following Notification:

Citation

1. This Notification may be cited as the Common Gaming Houses (Exemption) (No. 29) Notification 2012.

Exemption

2.—(1) The Minister hereby exempts Resorts World at Sentosa Pte. Ltd. from the provisions of the Act in respect of the "Genting Rewards Member Profile Update" promotion to be held from 1st August 2012 to 31st December 2012 (both dates inclusive) and the draws to be held on 1st October 2012 and 2nd January 2013, respectively, at 3 p.m. at the Festive Hotel Basement 1 Membership Office of Resorts World at Sentosa Pte. Ltd.

(2) The exemption is subject to compliance by Resorts World at Sentosa Pte. Ltd. with the conditions specified in the Schedule.

THE SCHEDULE

Paragraph 2

CONDITIONS

- 1. The methodology of the promotion, the details of the prizes to be distributed, their manner of distribution and, if the winners are determined solely or partly by a draw, the time, date and place of the draw, shall be disclosed in printed publicity material, copies of which shall be freely available to all participants.
- 2. The draw shall be conducted by persons in the employment of Resorts World at Sentosa Pte. Ltd. only.
- 3. The draw shall be conducted in public.
- 4. Any draw by means of a computerised system which is not conducted in public shall be witnessed and audited by a public accountant who is not in the employment of Resorts World at Sentosa Pte. Ltd.
- 5. The draw shall not involve the use of any game, method, device, scheme or competition declared by the Minister in a notification under section 2(3) of the Act.
- 6. The draw shall not involve the use of any instrument or appliance for gaming declared by the Minister in a notification under section 2(4) of the Act.
- 7. Resorts World at Sentosa Pte. Ltd. shall, before the start of any draw, undertake to ensure that
 - (a) all winners are notified by ordinary post or phone; and
 - (*b*) an audited statement of accounts shall, together with the results of the draw, be sent by registered post to the Head, Specialised Crime Policy Branch, Criminal Investigation Department, no later than 3rd April 2013.
